Draft Minutes of General Body Meeting held on 26th November, 2013 during 48th Annual Conference at Main Hall of Hotel Grand Hyatt Convention Centre in Mumbai

Secretary thanked the executive council for continuous help during the year. He also thanked the past presidents, Executive Trustee Dr. Rajeev Ahuja and the board of trustees for their constant advice and active supervisory role in functioning of the association. On many occasions valuable advice from past executive trustee Dr. J. R. Jaju was of immense help. Secretary specially thanked Dr. Arun Kumar Singh for sharing his wisdom of his secretarial years as well as continuing to manage the web site of association, aptly supported by academic colleagues of his department at KGMC, and Dr. Faisal Ameer. He also thanked Dr. Vijay Kumar for secretarial help in noting down minutes during EC and GB Meetings.

7. Treasurer's report and accounts for the year 2012-13

Respected Mr. President, Mr. President-Elect, fellow Office Bearers, Executive Committee Members and all the esteemed dear members of our beloved Association

It gives me great pleasure to present the Treasurer's report for the year 2012-13. Our association is rapidly growing; more importantly new members are joining from all parts of the country, which is wonderful for the future of our specialty in our country. We have now 1430 members till date.

Our Association is in a fairly sound financial condition with more than 3.6 Crores as investments & in Bank Accounts. With the generous grant of Rs. 1.65 Lacs from Ethicon for three CMEs each, we are continuing to support three APSI Ethicon PG CME courses, one during the Annual Meeting and two additional midterm CMEs each year. We are now in a much better position to support our journal. We have increased our Journal Corpus to Rs. 46.6 Lacs, which will substantially help the Journal to slowly become financially independent and remain truly open access, more details of course shall be available from the editor.

In addition to payment of International Dues to IPRAS (Rs. 88,263) as well as to the Asia Pacific Section of IPRAS (Rs. 4,20,713), we are able to distribute about Rs 15 Lacs per year towards various existing Awards, Grants and Fellowships for our members. The Trustees have increased all the corpus amounts by roughly 10 percent of original corpus, the Executive Trustee shall elaborate on this matter.

For IPad applications the APSI Treasury could transfer total Rs 5.5 Lacs including Funds from APSI Education Foundation and APSI Trust to IJPS Journal Account

The Treasurer's Office has received audited accounts of APSI Ethicon PG CME held at Nagpur. I am happy to inform that Convener Dr. Sanjeev Deshpande has done savings of Rs 39,187 from the course. On behalf of APSI, I congratulate him for the same. The accounts were open for inspection. The general body approved the accounts for accounting year 2012-13.

Last year Rs 7, 50, 000 were added to our corpus to start Dr. S. K. Bhatnagar Memorial Quiz Contest. We have received Rs 30,98,000 from the Organizers of APSICON 2012, held at Lucknow, till now. On behalf of APSI, I congratulate Dr. Arun Kumar Singh and his entire organizing committee for a memorable conference and substantial savings for the conference. After extraordinary efforts of past three consecutive Presidents namely Dr. Mukund Thatte, Dr. S. Raja Sabapathy and Dr. Arun Kumar Singh for not only doing memorable conferences but fetching Rs 1.4 Crores in last three years, we look forward to our President Dr. Ashok Gupta with great expectations and hope that he will break all records in savings from this conference. I wish to inform this august gathering that Maharashtra State Chapter of Association of Plastic Surgeons of India has formerly dissociated from APSI from financial year starting on 1st April 2013. I thank Dr. Shrirang Pandit, President MAPSI, Dr. Parag Sahasrabudhe, the dynamic Secretary of MAPSI, Dr. Mukund Thatte & Dr. Bimal Mody for their efforts. On behalf of APSI, I wish the newly formed

Association all the very best for their future. I wish to ascertain the members of Maharashtra Chapter that the interest generated from the funds namely Maharashtra Chapter Office Premises Fund, Fund for Scientific & Educational activity in Maharashtra & Bombay Fund will be sent to the new association each year for the academic use. At this point of time Dr. Sudhir Kumar Sing wanted to know about the origin of these funds. It was pointed out by the Executive Trustee that they were generated by Maharashtra chapter through several past APSICON. Secretary reassured the general body that only interest will be passed on to the newly formed body and corpus shall be handed over only when the new body is registered as a Trust or a Society, and if legally necessary then Charity Commissioner approves of such transfer and the general body approves of such transfer. Dr. Ahuja further specified this quoting discussions that had taken place in executive council. Dr. Amresh Baliarsing also commented on the utilization of these interests for activities in Mumbai and Maharashtra. The president said that he is in contact with Dr. Srirang Pandit, president of newly formed body, and awaiting their registration.

This leaves only Delhi chapter to be dissociated from APSI. I sincerely request the senior members, who are past presidents of APSI as well as members of Delhi Chapter to enhance the process of dissociation of Delhi Chapter from APSI. I thank Dr. P S Bhandari, Hon. Secretary of Delhi chapter for his efforts and cooperation. I am also very happy to inform you that in the last few years, with extraordinary savings from APSICONs and from generous donations, we have been able to create new Awards and Grants which will make our Association proud, such as Dr. K. S. Shekar's Plastic Surgeon of the year Award, Goa APSICON Research Award, Goa APSICON International Travelling Fellowship, XV IPRAS 2009 Humanitarian Fund & APSI Education Foundation Fund. Unfortunately we find barely one or two applications from 1400 odd members! I request all junior members especially to take advantage of these grants and prizes. All the details about the Grants and Prizes are available on our APSI Website. We were able to submit our audited amalgamated accounts to Income Tax Department as well as the Charity Commissioner within the stipulated time. This year the amalgamation of all audited accounts was done by the Sarda Pareek, Chartered Accountants, Mumbai. I thank Mr. Niranjan Joshi, CA for his efforts and help.

I sincerely thank Dr. Surajit Bhattacharya, Dr. Amresh Baliarsing, Dr. P. S. Bhandari, Dr. Arun Kumar Singh & Dr. Rajeev Ahuja for submitting their accounts within stipulated time. This allowed me to circulate the Amalgamated Audited Accounts to all the members of APSI by email, Courier and speed post, well in advance before submission. I do hope that you have all received them and gone through them. I wish to mention that the information available in APSI Directory is grossly inadequate. Out of 1420 APSI Members, we have 1247 active members. Only 846 members have email addresses. Out of 846 Emails sent 123 emails bounced back for a wrong email address. Out of remaining 421 members, only 234 members have telephone nos. registered in APSI Directory, where courier could be sent. For remaining 187 members I had to send the documents by a speed post. Out of total 421 couriers and speed posts sent, 89 were returned for wrong address and phone nos. Printing 12 page report related to audited accounts, and circulate it to 1400 plus members, means 16,800 pages + 1400 envelops. About 20 % letters are returned due to wrong address. Out of the letters delivered, 90 % probably are not even read. We should avoid this criminal waste of paper. Looking at the ever increase in cost of postage and courier services and in order to save paper, I request this august body to pass a resolution allowing the audited accounts to be circulated by email only. The hard copy can be sent only to members who specially request for the same.

"Resolved that the Audited Accounts of APSI will be circulated by email ONLY. Those members who require a hard copy, should write to the Treasurer, APSI. Providing and updating the email address in APSI Directory with Secretary will be the responsibility of the members. I urge all the members to update their Personal Details especially their email address with Hon. Secretary. It will help in easier and timely communication.

The resolution was adopted by voice vote. The secretary reminded that general body had in Goa already passed resolution about converting News Letter and associated notice of general body to electronic communication. All News Letters of past ten years are now loaded on the web site. They contain minutes of respective general body meetings as well. Secretary informed that our web site has a member section with ID and password for each member and each member can update their own data. Members were requested to keep their addresses and email ID updated with the association for prompt communication.

Appointment of Auditors

"Resolved that M/s SARDA & PAREEK, Chartered Accountants are hereby appointed as Statutory Auditors of Association of Plastic Surgeons of India for the financial year 2013 – 2014. One of the Trustees and Treasurer are hereby authorized to fix their remuneration."

The resolution was adopted unanimously

Authorization to Treasurer was required in several official legal matters. This is being carried out by office of treasurer very promptly, however such general body approval is necessary. The following resolution is thus approved unanimously by the general body.

"Resolved that Dr. Shailesh Ranade, Treasurer of the trust, be and is hereby authorized to sign the financial statements along with one Trustee."

"It is further resolved that Dr. Shailesh Ranade, Treasurer, be and is hereby authorized to represent the trust in case of representations to Income Tax, Trust Department and any other Statutory Authorities on behalf of trust."

"It is further resolved that Dr. Shailesh Ranade, Treasurer of the trust, be and is hereby authorized to sign the Income Tax financial statements along with one Trustee."

Authorization for usage of APSI PAN, TAN and Opening and Operating Bank Account

"Resolved that the following members are hereby authorized to open and operate Bank Account in the name and style "APSICON – (YEAR)" under the name of the trust. It is further resolved that the PAN, TAN and Address of APSI shall be used for opening such new account."

"It is further resolved that the Bank account such opened shall be closed after conclusion of such event within a reasonable period of time as decided by the Governing Council from time to time."

"It is further resolved that the Financial Statements of such event shall be prepared each year end, as at 31st march each year and a Audited copy of such financial statements, duly signed by all the office bearers of such event and statutory auditors appointed for that purpose shall be submitted before 31st May each year to the treasurer."

These resolutions were required for smooth financial activities related to the annual conferences. It was unanimously approved. Both treasurer and secretary were asked by general body to issue appropriately worded letters of recommendation to the incoming chairman of the organizing committee of APSICON as per the requirement of the bank where they wish to open such bank account.

I would like to thank Dr. Rajeev Ahuja, Executive Trustees for his constant support and guidance. I thank our President Dr. Ashok Gupta, Immediate Past President, Dr. Arun Kumar Singh & Dr. Atulkumar Shah our Hon. Secretary who I had the pleasure and Privilege to work with. I thank all the members of the Board of Trustees, Executive Council and all the members of APSI for their constant support. I would be failing in my duties, if I did not humbly thank all the members of APSI for their wholehearted support. I thank you all for a patient hearing.

The report of the treasurer was approved. Proposed by Dr. G. Balakrishnan and seconded by Dr. Gautam Biswas.

The secretary informed about that the next annual conference shall be in third week of October, and the general Body meeting shall be held on 18th of October,2014 in Chandigarh. Much before that date all filings of returns will be required to be done. It is therefore resolved that "the treasurer and the executive trustee are authorized to receive amalgamate and prepare the accounts for year 2013-14, get them audited, circulate electronically amongst members and file income tax returns and charity commission report on respective due dates." Proposed by Dr. Subodh Kumar Singh and seconded by Dr. Hari Venkatramani.

8. Executive Trustee's report

Dr. Ahuja introduced the current trustees to the general body and screened the accounts till 31st March, 2013. Corpus of 3.646 crores is accumulated till that date. About eleven lakh are in savings, while remaining amount is all invested. A small balance amount related to 9th IPRAS fund has also come to APSI, thus concluding the transfer of that corpus. Aout 56 lakh were received from Coimbatore conference, 1.3 lakh was donated by Dr. Ahuja out of the research grant that he received and Goa ISAPS course has donated Rs. 2 Lakh and will keep augmenting the corpus for a suitable activity later. 7.5 Lakh was received for starting Dr. S. K. Bhatnagar quiz. The Post Graduate course related Professional development course fund has been augmented by donation from me and another amount from savings of Hyderabad Corpus conducted by Dr. Mukunda Reddy.

Since no corpuses were actually augmented for past several years, we have gone ahead and augmented all corpuses existing for more than five years by ten percent of their existing corpus amount as well as rounded off to the nearest thousand. Thus at Lucknow General Body has recommended to augment Peet Prize corpus by fifty thousand, instead it receives one lakh. The general body resolved to approve the increase in the corpus as has been explained by executive trustee and approved by the Trustees' Meeting recently concluded as well as approved by executives.

Several amounts are locked up because annual successions of trustees have not been intimated to the authorities in time. We have started the process of producing the documents and certificates and file with the charity commissioner. Dr. Ahuja profusely thanked Dr. Shailesh Ranade for this mammoth task.

Address change process has been started as we have lost some TDS refunds. This was resolved at Lucknow to officially register address of the treasurer for all APSI activities with financial institutions, Charity Commissioner, Registrar of Societies etc.

All the amalgamated balance sheets were circulated, presented by treasurer here before me and have been duly passed by you. As of now Trust is operating old bank accounts in Chennai and Mumbai; and has no separate account in Delhi. The account approved by general body last time in name of APSI Corpus etc. could not be opened as succession of trustees has to be approved by the charity commissioner.

Please realized the importance and impact of the resolution approved by you just now that was moved by the treasurer about co-authorizing him to sign the balance sheet along with trustee.

In March 2013 EC meeting, sum of 4.5 Lakh was approved for I Pad applications in addition to one Lakh for journal expenditure. This was approved by EC and was disbursed before the end of financial year, so

as to help APSI in the expenditure. Dr. Ahuja sought approval of GB for these two disbursements done in March 2013, General Body approved of these transactions unanimously.

Share from life membership to journal corpus was not carried out. The trust has relocated sum of five lack rupees from life membership fund to journal funs as one time measures to take care of all past life members. General Body approved of this unanimously.

The journal corpus stands at 47 lakh and now as resolved in past and again re resolved in Lucknow, 10 % of savings of all APSICONs in future as well as Rs. 5000 from each life membership fee of 15,000 will go to journal corpus. Dr. Ahuja stressed that we must be the richest journal in the world.

Dr. K S Shekar has completed his terms as chairman and the board has recommended name of Dr. Suresh Gupta as chairman of the board of trustees. The general body welcomed the appointment of Dr. Gupta as Chairman. He will be chairman as long as he is a trustee. The trust has recommended induction of Dr. Mukund Thatte for the vacancy in the board. The general Body approved of this appointment. The appointment will start from end of this general body and will have period of five years. After the current Change in Board of Trustees the following is the reconstituted board of trustees and it stands duly approved by the General Body.

At this point Dr. Dhirendra Kumar Patil wanted to increase the utilization of the funds available with APSI. Dr. Ahuja informed that the majority of our fund is for a cause and the interest is used for awards or professorships or journal or international dues. There is not much buffer fund as such. The reason why the dedicated corpuses were increased and money was given to journal was also in the same lines of putting all our money to best use. All dedicated funds are properly invested and are earning.

The report of Executive Trustee along with appointment of new board of trustees was unanimously approved. General body also approved the corpus enhancements and adjustments as specified by Executive Trustee. Proposed by Dr. Jiten Kulkarni and seconded by Dr. Ankur bhatnagar

9. Editor's report and Journal accounts for the year 2012-13

It has been a pleasure to be here in the fifth year of the journal activity. Our H Index has reached nine. Android and I Pad apps have sizably increased our e visibility. There is increase in citations and Scopus over view for set of documents is now available. Of 682 documents that were considered, most are in last five years. Ours is most gadget friendly journal. Quick response code is now generated for each presentation. December 2013 issue is already on line with QR Code and apps. Dr. Faisal Ameer was instrumental in devising the android application. Journal is optimized for I Pod and I Pad. December 2013 issue is already online. IJPS is a free down load on I Pad. It can be downloaded directly from Apple apps store. After down loading one can read it off line. Editor also gave details of searching, viewing and copying

facility available through these electronic advances. He stated that there will be very bright future for electronic and I Pad. Our MOU with Medknow for I Pad does specify recurrent conversion cost, however 45 % of generated revenue will be earned by APSI in future.

271 articles came for publication in 2013. The rejection rate is also decreasing. Overseas submissions are nearly 25 %, and is as high as 113 in 2013. English speaking Asian countries and eastern European countries are targeted for article submission. Number of pages are increasing, however number of subscription also have to increase. The Editor deliberated on down load statistics. Total article download is frequently seen. Theme issues have also performed very well. I Phone and I Pad owners have frequented our site, and it has made a business sense in starting that app. Many of them are new visitors. Visits from surfers in India are of longer duration. SJR indicator confirmed that our impact factor has increased from 0.5 to 0.7. This had led good authors to submit their manuscripts to IJPS. Survey, review articles and controversial articles will further improve the impact factor. He asked members to site publications of IJPS. OVID open access gives opportunity for cross reference siting opportunity, a leading platform used by nearly 12,000 institutes globally.

Dr. Surajit Bhattacharya stated that The Dr. Mira Sen Banerjee article for December 2013 has come from Dr. Davit Elliot. Many more Review articles, articles with multi-centric surveys and high level of evidence must come to IJPS. Case reports if, meticulously written are also welcome, however their success rate so far is less than 10 %. Some manuscripts are pending revisions by authors or referees.

Plagiarism has bothered us. In Indian Journal of Urology, such article was published and stands withdrawn officially, however still stands on their e-portal. Our culture, that whatever that has been published belongs to all needs to be changed. Copy and Paste does not work anymore after excellent software that immediately pick up the source from where the words or lines are picked up.

The Corpus for journal has become healthier, thanks to efforts from all of you. The printing and postage has been increasing. The Journal therefore needs more funds. Because number of very good pending articles is increasing. Before IJPS loses these articles, one has to increase number of pages. Unless more subscriptions are generated and more advertisements are received, the corpus will not be sufficient to serve to the need of the journal. Talk about IJPS at all possible places. He stated that as of now the idea of IJPS becoming official journal of IPRAS –APS section has been dropped after the discussions that took place during last IPRAS meeting.

Dr. Bhattacharya also stated that next year will be his sixth and last year as editor of IJPS and that it would have been best to have a future editor starting to work with him one year in advance. Journal is a very jealous girlfriend and needs at least two hours every day.

Amidst standing ovation and loud applause Dr. Surajit Bhattacharya was greeted for his excellent editorship and the report of editor as well as the accounts of editor were passed. Proposed by Dr. Ravi Mahajan and seconded by Dr. S.S. Chaterjee

10. Introducing the incoming President

At this point the secretary sought permission of chair and of the general body to deviate from the list of agenda so as to introduce the incoming president for 2014. The secretary read from screen the laurels and academic expertise earned by Dr. Ramesh Kumar Sharma. The general body continued to applause while the presidential medallion was garlanded. In tradition, Dr. Ashok Gupta was honored with "outgoing

president's medal", past president pin and a certificate of appreciation digitally signed by members of executive council and the trust.

Remarks by the Incoming President, Dr. Ramesh Sharma and outline of activities for the year of his president ship including plans for APSICON-2014 could have normally followed, but not doing that the remaining agenda were resumed.

11. Matters arising out of the executive committee meetings held on 21-03-2013 and 25-11-2013

Matters arising out of the executive committee meetings held on 21-03-2013 and 25-11-2013 were next brought to the notice of general body for their information and necessary approvals or resolutions.

- A Letter received from Dr. Lokesh Kumar about APSI and APSI Trust relationship and was discussed during midterm meeting of Executive council on 21-3-13. Committee was appointed under chairmanship of Prof. Mathangi Ramakrishnan, with past treasurers Dr. P.K. Bilwani, Dr. Bimal Modi and Dr. Lokesh Kumar as members. Several improving measures were suggested and have been implemented after checking their legal standing. Clue was taken from a legal opinion taken in past during secretary ship of Dr. Rajeev Ahuja and also several inputs from the Chartered accountants and agency hired by association for change of trustee intimation work.
- Another letter from Dr. Lokesh Kumar discussed at the March meeting was about international dues being paid to IPRAS and IPRAS-APS. He inquired about benefits and special privileges enjoyed by APSI from these international bodies. A committee under chairman ship of past president and trustee Dr. V. Bhattacharya was constituted to look into the available accounts and other correspondences. In March meeting it was decided that we will continue to look into the affairs of both these bodies, however we should pay the dues as and when the invoices are received from them. The secretary informed that there have been information's received from both these body after writing to them and also from other sources. APSI wishes to continue to watch the activities and spending of these bodies so as to decide future line of association with these international bodies.

At this point Dr. Rajeev Ahuja shared some documents with members of general body and pointed out at the amount of money spent by IPRAS on travel in past two years. Of collection of 3.6 Lakh euro collected as international dues in a particular year, spending was 4.2 Lakh euro and 80% of this was spent on travel. He also pointed out that The Chile government has filed a tax evasion case against the Zita Congress that runs executive office of IPRAS and had managed the Chile IPRAS conference. Dr. Ahuja further stated that several countries have already stopped paying international dues to IPRAS. China had won the bid for 2015 congress even though it had not cleared the international dues. The 2015 congress has however been withdrawn from China and entrusted to Vienna - Austria for March 2015. Belgium, the bid winners for 2017 congress has announced their inability to conduct the congress if Zita is forced upon them as congress organizers.

Dr. Ashok Kumar Gupta appraised members about the recent developments. It was brought out that the China Government was involved in denial of holding IPRAS congress in China in 2015 as there are two Plastic Surgery societies in China. Dr. Gupta wanted the continuation of International dues payment. Dr. Bhattacharya stated that last they had a meeting in August, however new information keeps coming. Dr. Lokesh Kumar stated that this committee should continue to collect information and decide line of action with regards to payment of dues. Dr. Ramesh Sharma reassured the general

body that the available information shall again be deliberated upon in the next midterm executive meeting to be held in February 2014.

• APSI Junior Best Paper and McNeil Audio Visual Award merger Correction is necessary as the resolution was passed by Lucknow general body about adding the McNeil corpus to Junior best paper corpus because now no longer the 35 mm slides are used. Dr. Rajeev Ahuja stated that the trust did not carry this merger and the legal opinion was sought that went against such merger. Dr. Ashok Gupta stated that he also had telephonic talk with Dr. Jaju in this regards. Dr. Ashok Gupta sought permission of house to add name of founder and donor Dr. Jaju to this award. Suggestions were invited from house, however no further discussion took place on this aspect.

"Resolved that the Lucknow General Body resolution of merging the Junior Best Paper corpus and McNeil Audio Visual Corpus stands revoked."

Dr. Gautam Biswas again brought out the point of deciding in this meeting only to stop paying to IPRAS. Dr. Ashok Gupta stated that we cannot discuss the activities of other association. Dr. Bhattacharya wanted the president to allow about four members to express their opinion on this matter. Dr. Ashok Gupta stated that members can write to Dr. Bhattacharya and committee including past three treasurers Dr. Bimal Modi, Dr. Bilwani and Dr. Lokesh Kumar, as also Dr. G. S. Kalra, Dr. Ramesh Sharma and Dr. Mukund Thatte as well as ex officio President, Secretary and Treasurer. Dr. Ahuja stated that after the August meeting of this subcommittee, fresh documents have surfaced. Dr. Shashank Shringarpure wanted the minutes of Executive Council as well as of all subcommittee meetings must be made available to all members. Dr. Ashok Gupta wanted to know as to what was the result of the query letter sent to IPRAS and IPRAS-APS. Dr. Shailesh Ranade stated that a point to point reply was received from APS section. Only a sheet of 2012 accounts as well as 2013 budget were received. Dr. Lokesh Kumar stated that even though the balance sheet has been received, we can have objections to the way the money has been spent. Dr. Raja Sabapathy stated that the IPRAS president is here in the hotel, and the Executive Council could have asked her for the explanations. Both Dr. Lokesh Kumar and Dr. Ahuja raised their voice in complete disagreement stating that Madam President of IPRAS is a guest and has not been called to be in the witness box for us. We cannot proceed to crucify her, instead we need to discuss what to do with our relations with IPRAS and communicate same to them. Dr. Lokesh Kumar warned that decision may not come for next two or three years. Dr. V. Bhattacharya stated that the committee will soon meet and reach out to a conclusion that will be notified to the general body. Chairman of the trust Dr. Suresh Gupta wanted inclusion of Dr. Rajeev Ahuja in this committee. Dr. Mukund Thatte gave his opinion in agreement to the process of subcommittee looking into the matter. Dr. Thatte warned that deciding on hearsay information may amount to a king of defamation. Dr. Subodh Kumar Singh stated that many of members of this association are in dark as to why APSI should be part of IPRAS. Dr. Bhattacharya further clarified that no decision has been arrived at. Dr. K S Shekar raised his concerns stating that we are unnecessarily prolonging this discussions. It is like asking weather India should be part of UNO or of SAARC. We were fortunate to organize two elaborate IPRAS congresses. It brought so much prestige. Dr. Ashok Gupta stated that the national delegate to 2015 congress must go prepared to find out the IPRAS affairs. Dr.Dhirendra Kumar Patil was of opinion that we need to decide on one or other side rather than continuing the ambiguity. Dr. Suresh Gupta reminded that first APS sectional meeting was held in 1970 in India and from 1963 we are participating in IPRAS. It may be possible that the character of IPRAS might have changed. Dr. Ahuja stressed that delaying the payment shall not cut off the relationship. Dr. Bhattacharya stated that further meetings will involve more members including Dr. Ahuja and after going through adequate documents and informing general body a final decision will be taken.

- Secretary further announced that Dr. Shekar wishes to augment the corpus by another sum, for which Rs. Two Lakh is being handed over now and Dr. Shekar will add further Rs. Three lakh in coming years. We thank Dr. Shekar for this gesture. Secretary also thanked Dr. B. Anathram, the convener of the task force for all the administrative help.
- Topic for Dr. R. N. Sharma Symposium to be held during Chandigarh Conference

Subjects suggested by Executive Council – a.)Foot and Ankle Reconstruction including Diabetes Foot b.)Scalp and Calverial Reconstruction and c.)Orbital Reconstruction.

No further topics came from the floor and general consensus was in favour of topic of foot and ankle reconstruction. Dr. Hari Venkatramani shall be the convener for the symposium.

medal, a certificate and a cash prize from among the interest generated from the corpus. The organizing committee of the APSICON shall announce this while inviting for the conference abstracts."

15th IPRAS 2009 Humanitarian Activities Fund for 2015

- 1. The fund will be governed by general rules applicable to corpuses managed by APSI Trust, the usual rules of APSI Trust will apply in disbursing the interest and in augmenting the corpus on annual basis.
- 2. If there is no proposal in a year the entire interest generated will be used to augment the corpus.
- 3. It will be specifically used for organizing humanitarian activities on behalf of APSI, like organizing 'Surgical Camps' at remote places with the help of local charitable groups or medical colleges, where Plastic Surgery facilities don't exist.
- 4. The proposals will be submitted to Secretary, APSI at least 8 months before the camp activity. The last date for a particular year is 31st July of previous year.
- 5. All proposals should include the complete plan, the co-hosts (and their role), financial details, list of surgeons and other staff, food and stay arrangements, venue of surgery etc. Proposals should be comprehensive in all aspects.
- 6. The Committee to consider such proposals will consist of the President and Secretary of APSI; President, Chairman and Secretary General of IPRAS-2009, and Dr. Chanjiv Singh (Chairman-Humanitarian Committee-IPRAS). This group (Secretary APSI) will present the proposal to the APSI Executive and an electronic approval of the APSI Executive will be taken by him/her to expedite the decision.
- 7. Surgeons from overseas will need MCI and / or State Medical Council Registration as per rule applicable at the time. This will be ensured by the organizers.
- 8. A separate bank account will be opened for this purpose by the Chief Organizer and it will have a minimum of two signatories, who will be authorized by APSI Executive.to operate this account jointly,
- 9. This is a financial support of the nature of one time lump sum grant

Draft BYLAWS

THE FEDERATION OF PLASTIC RECONSTRUCTIVE & AESTHETIC SURGERY SOCIETIES OF SAARC COUNTRIES

Article I Name and Location:

Section 1

Name: The name of the organization shall be

"FEDERATION OF PLASTIC RECONSTRUCTIVE AND AESTHETIC SURGERY SOCIETIES of SAARC COUNTRIES" (FPRASS -SAARC).

Section 2:

Location: Location of office(s) of the Federation shall be determined from time to time by the Board of Directors.

Article II Participating Organizations:

All countries of SAARC region with at least 5 Plastic Surgeons and a fully registered Plastic Surgery Association will have full representation within this federation.

Plastic Surgeons from other SAARC nations, not eligible under this clause, shall be allowed participation without right to hold office or vote and may be represented by a senior Plastic Surgeon nominated from their respective country.

Article III Objectives:

The objectives of the Federation shall be:

- 1. To promote and advance the art and science of Plastic Surgery in the entire SAARC region and to maintain highest standards of professional skill and competence among its members.
- 2. To establish a forum for the exchange of knowledge, experiences and opinion through discussion, study, meetings, seminars and publications.
- 3. To stimulate research and investigation in the in the fields of Plastic Reconstructive and aesthetic Surgery
- 4. To foster and coordinate training in Plastic, Reconstructive and Aesthetic Surgery at both undergraduate and postgraduate teaching programs and to encourage exchange program and visiting professorship.
- 4. To disseminate information regarding clinical and scientific progress in the field of Plastic Surgery,
- 5. To project correct image of this specialty and Plastic Surgeons in this region and take effective measures to eliminate quackery as is consistent with the public interest.
- 6. To affiliate with and promote other organizations with similar objectives including sub-specialties like burns, hand, cranio-facial, aesthetic and onco-plastic, Microsurgery, Lasers, etc.
- 7. To provide humanitarian assistance within and outside this region as and when required and deemed feasible.

Article IV Membership:

Section 1

Members: All full members in good standing of Plastic Surgery Associations of participating countries from SAARC region shall constitute active membership of the Federation.

Section 2

The participating Associations shall provide a valid membership list of all their current and new full members to FPRASS-SAARC Secretariat.

Article V Board of Directors & Officers:

Section 1

The Board:

The board of directors shall consist of nominated members from participating countries. For a country which has five or less national members there shall be one member but without voting rights. Countries with more than five but up to twenty members shall have one member with voting rights. Twenty to less than fifty shall have one more member on the board of directors. Fifty to hundred, shall entitle one additional member on the board from that country. There after one more member for next two hundred members. No country shall have more than six members. The above members are over and above the President, the President Elect and the Secretary General to represent it on the Board of Directors of FPRASS - SAARC for a term of two (2) years. Together, they will constitute the Board of Directors

Section 2

Officers:

Officers of the Association shall be the President, President Elect and Secretary General. They shall hold position for a two year period. (The first secretary general shall hold a term of four years and eligible for re-election for one more term). The secretary general will be eligible for re-election for another term of two years.

Section 3

Eligibility:

All officers must be active members of their respective national association for not less than five (5) years.

Section 4

Term of office:

Term of office of all members nominated for the Board of Directors shall be two (2) years that will expire at the time of Annual General Body meeting.

Section 5

Election:

The Officers of the board shall be elected by the members of the board. Any full member of more than 15 years good standing of the participating country, which has voting right can present his candidature for the post of President elect or the secretary general. His candidature must be proposed and seconded by two members from the participating countries. More than one nomination for a post will entail election by secret ballot. The President elect shall ordinarily be automatically elevated as the President. In case one of the Board of Director member is elected to the post of President – elect or the Secretary General, his vacancy shall be filled by a nomination from the same country.

Section 6

Duties of Officers:

President:

The President shall be the chief executive officer of the Federation, shall serve as the chairperson of Board of Directors, and shall serve as ex-officio member with right to vote on all committees. He will represent entire SAARC region as section of IPRAS. The President shall preside over all meetings of the Board and membership of the Federation.

President Elect:

Same as above in absence / insolvency of the President

Secretary General:

The Secretary general shall be responsible for keeping the minutes of all meetings of the members and Board of Directors, shall see that all notices are properly sent out. He shall be the custodian of corporate seal and records, keep a roster of all members, shall organize and arrange meetings, shall prepare the annual report and perform all such duties as are incident to his office or prescribed by the Board of Directors. He shall also be responsible for running the web site of the federation.

Article VI Committees:

Section 1

Standing committees:

Standing Committees of the Federation shall consist of

- a)Scientific Committee,
- b) Publication Committee,
- c) Ethics Committee,
- d) By-Laws Committee,
- e) Humanitarian aid committee,
- f) Public Relations Committee.
- g) Co-ordination Committee.

In addition special committees of the Federation may be constituted by the President to serve the needs of the Federation.

Section 2

Compilation:

Each year the President shall recommend the names of at least three (3) members including a chair person for each of the standing and special committees to the Board of Directors for approval.

Chairperson of all committees shall be active member of the Federation. Each person so appointed shall serve a term of two (2) years or until such time that a successor is appointed.

Article VII Finances

Section 1 Fiscal Period: Fiscal period of the Federation shall be from January 1 to December 31st.

Section 2

Operating Budget:

There shall be no membership dues to begin with for the participating Associations. However, it may be added if the need is felt at a later date.

The secretary general shall maintain the accounts.

This fund shall be made available to the President for FPRASS-SAARC activities.

Section 3

Gifts: The Board of Directors may accept any contribution, gift or bequest to the Federation.

Section 4

Report: At the end of each fiscal year the secretary general shall collect information about dedicated fund and its utilization from all participating Associations and present a report to the membership during bi-annual meeting of the Federation.

Article VIII Meeting and Voting

Section 1

Meetings: Meeting of the Federation shall be held every two years on rotation among participating countries. The Presidents of the National Associations shall determine location and timing of the meeting.

Section 2

Special Meetings: The President or a majority of Board of Directors may call a special meeting of the Federation.

Section 3

Notice of Meetings: A notice stating the place, day and time of the bi-annual or special meeting shall be sent to all members by letter and/or e-mail at least ninety (90) days prior to the annual meeting and thirty (30) days prior to the date of any special meeting.

Section 4

Voting: At all meetings of the Federation, only members of participating countries who have registered national societies with more than five members have the right to vote. Voting must be in person and not by proxy. In exceptional situations the member can send his vote by email from his registered email address. A simple majority of voting members at the meeting shall decide all ordinary business except any changes in these by-laws. In case of a tie, the President shall have a casting vote.

Article IX Amendments

Section 1

Proposal: Amendment of these Bylaws may be proposed by the Board of Directors, Bylaws Committee or by at least five (5) active members of board of directors. It must be submitted to the President, at least ninety (90) days prior to board of directors meeting. A written notice of proposed Bylaws changes shall be sent by letter and/or e-mail, to all eligible voting members, at least thirty (30) days prior to the meeting.

Section 2

A two third majority of voting members present at the meeting is required for approval of amendments. Amendment shall be ratified by a majority vote of members of all participating Associations at their respective annual meetings before final approval.

Article X Dissolution

The Federation shall use its funds only to accomplish the purpose specified in the Bylaws. No part of the said funds shall inure to the benefit of or distributed to any member of the Federation.

In the event of dissolution of the Federation, the Board of Directors shall after paying or making provision for the payment of all liabilities of the Federation, distribute the remaining assets to such organizations operated for one or more of the purposes contained in the articles of Incorporation and the Bylaws of the Federation.

Members of APSI are requested to send their comments on these bylaws to the secretary. We propose to adopt these bylaws during next general body meeting.
