Dear Colleagues,

It is my pleasure to present before you this issue of the newsletter of the Association of Plastic Surgeons of India. I shall be completing third year of my secretary-ship at the end of this

year. Looking back, I feel I have worked sincerely and earnestly for the association. I have ensured that the communication with members is prompt. We have seen a quantum jump in our membership. 234 new members have joined the association during the last 3 years. A number of new initiatives have been taken. Our newsletter has been made electronic as well, making its viewing and archiving easier. A proper web site of the association has been made functional. Since January this year Dr. Mukunda Reddy is hosting the web site and would maintain it out of APSICON-2006 funds. Perhaps for the first time in the history of the association life membership certificates have been prepared and given to its esteemed members.

The membership directory is being renewed, updated and shall be shortly before you.

We are in the process of starting accredition courses of the association. It will be for the benefit of younger members and all others who wish to refresh their knowledge. It is becoming possible due to the initiative taken by Dr. R.B. Ahuja, our immediate past president. A microsurgery course has been planned in January at Mumbai, faciomaxillary course in July at Chennai and skull base and craniofacial course at Pune along with APSICON-2007. The blue print for the courses has been published in the March, 2006 issue of the newsletter. I would request the members to go through it and give their comments. A legal cell is in the offing. Dr. Atul Shah is looking after it. The amendments to the constitution have been registered, primarily due to efforts of Dr. S.R. Tambewekar. Legal Cell in APSI

With the inputs from the members of the cell and the members of APSI, the following points have emerged as the areas which need exploration, consensus and implementation.

1. Legal intricacies of Consent and elaborate consent form.

Treating some one is a contract. Obtaining consent from patient and relatives is thus governed by Indian Contract Act. Prior to the consumer protection act, many disputes were taken to civil court under this act. Patient, by walking in and asking for treatment of his ailment gives implied consent. This situation however changes as soon as some controversy arises between a doctor and relatives or a patient. It is therefore necessary that an informed written consent be obtained from patient and relatives. In case of emergency, at least the situation needs to be explained to the relatives in presence of some witness, and written detailed consent be obtained as soon as possible. In court many times patient or relatives tell that consent was obtained on blank form, and without any detailing. It has been strongly suggested that wherever

possible, patient or relative should write the consent in their own handwritings. In case of printed forms, patient or relatives must be asked to write in their hand writings that they have been satisfactorily explained about the treatment and the out come and that all the blanks in the said form have been filled before they signed the consent form. It could also be beneficial to obtain signature of one witness, especially if the clinician foresees some legal tangle later on.

2. Standard format for imparting pre procedure information.

During explaining, one may miss out on a point, or may need to present a particular out come in different language so that the patient does not get unnecessarily alarmed. If a document containing all necessary information on the outcome of a particular procedure is stored in computer, or printed, it can be referred, as well as passed on to the patient and the relatives. Legal cell wishes to standardize such pre-procedure information document, some of which will be made available during APSICON for awareness and creating consensus.

3. Usage of word Plastic Surgeon and Cosmetic Surgeon, and its restrictions.

Many poorly qualified individuals have been using these phrases and luring ignorant public. When their results are unmatched, the specialty as a whole bears the blame. Unfortunately, the association can not prevent people from using these phrases. One possible avenue is to obtain trade mark or register the phrases with appropriate authorities, thereby the association obtains intellectual property rights over such phrases, and then allows the members to use them. Legal experts in the field of trade marks etc. have raised a caution here that phrases in common use are generally not granted registration, and the association will have to impress upon the authorities in very elaborate manner, as to how and why the misuse of such names is detrimental to population. A remedy is available through code of conduct wide section 7.20, stating that "A Physician shall not claim to be specialist unless he has a special qualification in that branch." Association or local groups have to obtain legal restriction by filing suits against miscreants.

4. Advertising

Amended Regulations relating to the Professional Conduct, Etiquette and Ethics for registered medical practitioners are in force since they were published on 6, April, 2002 in Part III, Section 4 of the Gazette of India. Drugs and Magic Remedies (Objectionable Advertisement) Act, 1954 is also attracted in case of advertisements with high claims. Members must be aware that strict codes of conduct are enforced for Chartered accountants, Architects and Lawyers. They are decently restraining from advertising their services. Relevant sections from regulations of 2002 are reproduced here.

"6.1 Advertising:

6.1.1 Soliciting of patients directly or indirectly, by a physician, by a group of physicians or by institutions or organisations is unethical. A physician shall not make use of him / her (or his / her name) as subject of any form or manner of advertising or publicity through any mode either alone or in conjunction with others which is of such a character as to invite attention to him or to his qualification, professional position. skill, achievements, attainments, specialities, appointments, associations, affiliations or honours and/or of such character as would ordinarily result in his self aggrandisement. A physician shall not give to any person, whether for compensation or otherwise, any approval, recommendation, endorsement, certificate, report or statement with respect of any drug, medicine, nostrum remedy, surgical, or therapeutic article, apparatus or appliance or any commercial product or article with respect of any property, quality or use thereof or any test, demonstration or trial thereof, for use in connection with his name, signature, or photograph in any form or manner of advertising through any mode nor shall he boast of cases, operations, cures or remedies or permit the publication of report thereof through any mode. A medical practitioner is however permitted to make a formal announcement in press regarding the following:

- (1) On starting practice.
- (2) On change of type of practice.
- (3) On changing address.
- (4) On temporary absence from duty.
- (5) On resumption of another practice.
- (6) On succeeding to another practice.
- (7) Public declaration of charges.

6.1.2 Printing of self photograph, or any such material of publicity in the letter head or on sign board of the consulting room or any such clinical establishment shall be regarded as acts of self advertisement and unethical conduct on the part of the physician. However, printing of sketches, diagrams, picture of human system shall not be treated as unethical."

Those who extensively advertise are sitting on a volcano, and a complaint to a council can lead to severe inconveniences for them. The regulations further also state that-

"7.11 A physician should not contribute to the lay press articles and give interviews regarding diseases

and treatments which may have the effect of advertising himself or soliciting practices; but is open to write to the lay press under his own name on matters of public health, hygienic living or to deliver public lectures, give talks on the radio/TV/internet chat for the same purpose and send announcement of the same to lay press.

7.12 An institution run by a physician for a particular purpose such as a maternity home, nursing home, private hospital, rehabilitation centre or any type of training institution etc. may be advertised in the lay press, but such advertisements should not contain anything more than the name of the institution, type of patients admitted, type of training and other facilities offered and the fees.

7.13 It is improper for a physician to use an unusually large sign board and write on it anything other than his name, qualifications obtained from a University or a statutory body, titles and name of his speciality, registration number including the name of the State Medical Council under which registered. The same should be the contents of his prescription papers. It is improper to affix a signboard on a chemist's shop or in places where he does not reside or work.

8.2 It is made clear that any complaint with regard to professional misconduct can be brought before the appropriate Medical Council for Disciplinary action. Upon receipt of any complaint of professional misconduct, the appropriate Medical Council would hold an enquiry and give opportunity to the registered medical practitioner to be heard in person or by pleader. If the medical practitioner is found to be guilty of committing professional misconduct, the appropriate Medical Council may award such punishment as deemed necessary or may direct the removal altogether or for a specified period, from the register of the name of the delinquent registered practitioner. Deletion from the Register shall be widely publicized in local press as well as in the publications of different Medical Associations/ Societies/Bodies.

8.3 In case the punishment of removal from the register is for a limited period, the appropriate Council may also direct that the name so removed shall be restored in the register after the expiry of the period for which the name was ordered to be removed.

8.4 Decision on complaint against delinquent physician shall be taken within a time limit of 6 months.

8.5 During the pendency of the complaint the appropriate Council may restrain the physician from performing the procedure or practice which is under scrutiny.

8.6 Professional incompetence shall be judged by peer group as per guidelines prescribed by Medical Council of India."

Association may announce its views on advertising, and in case of non compliance, may discontinue the membership or stop calling such person to chair, present work, giving executive post and like. Association can also become complainant and present the misconduct to respective Medical Councils. It may be remembered that those who advertise their skills, obtain upper edge in eyes of public at the cost of rest of the equally competent law abiding colleagues.

5. Consumer Forum litigations.

Patients, relatives and lawyers have found less costly and less procedure intensive way of harassing treating physicians. There could be few genuine instances of negligence or deficiency of services, but by and large many cases in consumer forums are due to lack of communications and explanations to patient and relatives at all stages of management. Maintain proper and detailed records, obtain elaborate informed consent, keep patient informed of the progress, and manage charges properly are some of the ways of keeping out of litigations.

6. Negligence and IPC 304 A

Many times doctors are booked under IPC 304 and taken to custody when relatives have complained to police about negligence. Section 304 clearly deals with culpable homicide not amounting to murder. Supreme Court has issued specific directives defining medical negligence and using section 304 A that deals with causing death by negligence. Local police must be made aware of this directive.

7. Formation of Support groups at various levels. To stand united, to face mob fury or local print media in case of mishap in hospital or nursing home, to voice out for legal rights, our members need to establish support groups. All members must be provided with contact numbers of the support group volunteers. On a distress call some of us must reach the venue of mishap and render necessary help.

8. Legal awareness amongst members.

Association and local branches can organize mini conferences or law shops for updating members of their legal duties, rights, new acts and recent judgments.

9. Mediclaim

We are aware that many reconstructive procedures are classified as plastic surgery by the insurance companies and are denied claim. Also there is general trend among insurance companies to avoid elders taking mediclaim. Birth defects have been

excluded in many instances, creating hardship to the patients. Association needs to provide a list of procedures that essentially are of the reconstructive nature. At the same time members also must observe ethical restrain in raising claims.

10. Indemnity Insurance.

The premium rates for the medical indemnity insurance are highest for plastic surgeons. In some western countries premium is decided on number of surgeries carried out in a year. We pay premium of the sum insured for a single mishap, and for the entire year. Even after having obtained indemnity insurance, we have to face hardship as the lawyer provided by insurance company has different agenda on mind, and we have to appoint our own lawyer. Some state Medical Associations and National association are running professional protection schemes, and their membership has definite advantages. However one must remember that there is no alternative to proper record keeping and informing progress of management at all stages. 11. Legal Cell Corpus fund.

Legal cell can undertake formulation of prototype of detailed consent form, various pre procedure information documents, articles on current acts that are applicable in day to day practice, and organize e-workshops. These all activities will require funding, and a corpus must be created out of association existing funds, donations and contributions from members.

It is suggested that a slot be allowed in the Hyderabad Conference to deliberate on some of these issues in more detail, as well as to circulate some of the legal literature, probably as part of the proceedings of the conference. Some of the recent judgments involving Dr. Gupta from Delhi and Dr. Sada Shiva Murthy from Bangalore and others are worth discussing in such a slot, and these colleagues must be invited to share their experience in the respective court cases so that a general awareness gets created to keep a vigil at personal level to prevent and avoid common legal mistakes.
