

# **A REPORT**

Conquering new domains" and so the Prefix of SAMHITA – Compilation of knowledge. We had the privilege to serve a record 962 delegates.

For any conference to be successful a right mix of scientific content and hospitality is essential. We wanted to go a bit forward and decided to incorporate our social responsibilities as well. Green conferences are the way forward and it is only a matter of time when it will be the norm. Even before the conference started, a thousand trees were planted representing a tree for every delegate. Conferences bags and name tags were all eco friendly. To try to decrease the heaps of flex, sign boards were kept to the minimum and Jute and cloth were used wherever possible. The conference pen was a seed pen made of paper, which will grow into a tree after its purpose, is served. To keep the use of PET bottles to the minimum, a request to use water bubbles was wholeheartedly supported by our delegates. The delegates themselves suggested the use of carpooling from and to the airport and we were able to support with vans and buses.

On the 15th of November the **Prof. C.R. Sunderarajan Video Workshop** was held at Amrita Institute of Medical Sciences. Dr. Rajappan, the senior most practicing plastic surgeon in Kerala and the first to create a hospital dedicated to plastic surgery inaugurated it.

Video Samhita was about creating a compilation of



videos covering all subspecialties of plastic surgery. Making smaller duration videos and voicing them over to include all indications, technique, pearls and pitfalls made them interesting and easy to understand. All the members of APSI, whom we contacted were extremely positive about taking time out to make the videos as per our specification and were eager to share knowledge with our fellow members, unconditionally.

While calculating the time at our disposal and the availability of halls, we landed upon the number 108, while adjusting the total number of videos, which in fact is a very symbolic number for Indians being the fact that it represents the summation of all knowledge and as our whole concept was to share plastic surgical knowledge, to as great an extent as possible, we conceptualized showing 108 videos.

All the videos were made available to delegates from video download hubs and were mailed to them as well. The selfless transfer of knowledge, taking place among all the association members, in fact each one of us literally helping each other, has in real sense made it truly joyful.

It was imperative for us to safeguard the authorship of the videos with watermarking. We believe this would go a long way in transferring the real technical knowledge about our broad specialty and would help in bridging the knowledge gap between the experts in the field and the younger surgeons and would act as a first ever freely available video library created by Indian Plastic and Reconstructive Surgeons for the whole world, we say the whole world because whatever is good, is bound to attract attention.

The workshop was followed by a group photo under the statue of Maharshi Sushruta, which is the tallest in the world.

The rest of the programmes were held at Le Meridian Convention Centre, Kochi. On 16thDr.Charles Pinto CME was inaugurated by two senior plastic surgeons and teachers of Kerala, Prof. P.A. Thoams & Prof. Ramakrishnan Nair. Fifteen lectures were presented at the podium. Two lectures were done by teleconferencing, as the two foreign faculties had to cancel their trip due to some unavoidable reasons at the last minute. Dr. Vijay Gorantla, a renowned reconstructive surgeon from US, internationally known for his work in VCA talked from USA, on "Newer arenas in VCA – Future Prospects". Dr. Xu Lei, a well known hand surgeon from Fudan University, Shanghai, China talked on "Microsurgical Treatment of Lumbar Plexus Injuries".

The Conference Inaugural ceremony was held in the evening. The invocation song was sung by Prof Uma who herself had a tongue reconstruction. Two hand transplant patients, Manu and Jith, lighted the lamp.



Prof Valiyathan, renowned Cardiac Surgeon and the author of the book on Sushruta inaugurated the conference. He gave a detailed insight on the life and times of Sushruta and was acknowledged with a standing ovation. The inauguration was followed by heart rendering musical fantasy by the violin maestro, Dr L Subrmanium. At the end of the show, which included a ten minute standing ovation, he was swarmed by our members to seek blessings and to take selfies.

Master Classes: On all the three days of the conference, there were master classes from 7.30 to 8.30 am in 6 halls. One of the highlights was the programme on Hair restoration organised by Dr. Anil Garg and his excellent team. Mr. Michael Alatristae organised a course on Manual Lymphatic Drainage for lymphoedema.

The plenary session was held in the morning. On all the three days break away sessions were held simultaneously in 6 halls. Lead lectures, free papers and symposia were held in breakaway sessions.

The highlights of the plenary sessions are as follows:

The first day of the conference on 17th Nov 2017 was marked by Dr. A.C. Ganguly Memorial Lecture by Prof. Peter Dzeiwulski on "Total Wound Excision", Gillies Oration by Prof. Prabha Yadav on "Advocacy & Mass Education" and Sushruta Oration by Dr. Ronald Zukr on "Expanding Horizons of Reconstructive surgery"











Dr. R.N. Sharma Memorial Symposium was in two parts – first was on "Practical management of filarial lymhoedema", moderated by Dr. Manokaran G. and the second was on "Adopting craniofacial surgery to routine clinical practice" moderated by Prof. A.K. Singh

This was followed by presentation of Dr. Sam C Bose & Dr. Saroja Bose best paper on audit and research in plastic surgery by Dr. Anil Garg on "A histological and clinical evaluation of plasma as a graft holding solution and its efficacy in terms of hair growth and graft survival"

APSI best paper for junior plastic surgeons had 10 papers and the best paper award was won by Dr. Swapnil Dhake of Amrita Institute of Medical Sciences, Kochi for his paper "The immune process in allotransplant and its modulation in primary & secondary lymphatic draining sites- a qualitative study in small animal model"

Bolgatty Palace is a heritage building at the mouth of Cochin harbor, which is one of the most beautiful places in Kerala. It was the venue for the evening programs, the highlight of which was the exposure to Kerala culture performed by sixty artists for Kathakaly school of Trichur. It included Kathakali, Panchavadium, Mohiniattam, Kalari and many more. It was followed by a grand dinner under the starlit sky.

The highlights of second day on 18th Nov 2017 were Prof. C. Balakrishnan Oration by Dr. Mita Prasanna on "Pearls of wisdom in plastic surgery", Godrej Visiting Profesor Oration by Dr. Warren Breidenbach and Dr. M.M. Mukherji Oration by Dr. Peter Cordeiro on "Trends in breast reconstruction – autologous Vs implant reconstruction".

This was followed by Peet Prize session. The best paper award was won by Dr. Pawan Agarwal on "Rectus abdominis detrusor myoplasty (RADM) for acontractile/ hypocontractile bladder in spinal cord injury patients, preliminary report".

Dr. Ashok Koul Innovation Session, moderated by Prof. M. Lekshmi was another highlight, wherein 10 innovative ideas were presented.

After the cultural fest, on the penultimate day everyone had a culinary exposure to the traditional Kerala lunch served on a banana leaf. After three full days of scientific feast in the evening everyone enjoyed the live music and dinner at the riverside. Delegates spontaneously broke into their best dancing performances. Dr. Rajinder Nihate's presentation on his experiences in cycling across USA was very interesting and surely will encourage many more to follow him.

The third day on 19th Nov 2017 was marked by very interesting Dr. S.K. Bhatnagar Quiz Competition finals conducted by Dr. Sheeja Rajan, Dr. Jyoshid Balan and





their team. It was well appreciated by all.

Dr. Al Aly presented Dr. S.N. Sharma Endowment Lecture on "The history, massive weight loss body contouring: my journey"

The guest lecture, which needs special mention, is "Avenues of collaboration with ASPS" by Dr. Arun Gosain.

Valedictory was held at 12.00. The whole team of the organising committee was introduced. The incoming president Dr. Surajit Bhattacharya, on behalf of the delegates, lauded the efforts of the organizers and thanked them profusely for organizing such a wonderful conference.

Vision Document for APSI

#### 1 Objectives of the document and the strategic planning committee

#### 1.1 Background

The activities of APSI at present are the responsibility of the current President assisted by the Secretary and Treasurer. The role of the Secretary and Treasurer are confined to managing the day-to-day affairs of the association. The President defines the major policy goals. Unfortunately, due to the short span of time available during his or her term of one year the President is unable to contribute enough or plan long-term visionary projects. Hence the APSI is losing out in implementing long-term policies or activities that demands continued attention. This lacuna was brought to the attention by the Past Presidents' forum to the General Body of 2016 held in New The GB authorized the current President to form a Strategy Planning Delhi. Committee and provide a vision document for next 5 years. Once approved by the General Body this vision document is to act as a guiding principle on which the Presidents during the next five years can work in continuity for achieving the goals set in the vision document. Accordingly, the President co-opted Dr Raja Sabapathy, Dr Mukund Thatte, Dr Rajeev Ahuja to from the committee and the Hon Secretary Dr. Parag Sahasrabudhe and Treasurer Dr Shailesh Ranade to help in the preparation of the vision document. Inputs were taken from several other persons in relation to the training programme, curriculum, journal etc. The document has been prepared after deliberations among these people and subsequent revisions.

The committee will be in place for 5 years. The current President/ Secretary and treasurer of that year will be member of the committee during that year. The committee will have virtual or physical meetings twice a year. The Secretary will apprise the committee on progress of implementations and committee will give its

observations to the secretary who will keep GB informed every year and provide further suggestion.

#### 1.2 Objectives

- a) To define the long term visions of APSI
- b) To identify areas of action to be addressed by the office bearers for next five years and to formulate time bound action plan for each year.
- c) To identify special issues that need attention and further deliberations

#### 1.2 a) Defining long term visions of APSI

- i. APSI endeavors to provide opportunities to its members for self-development and help achieve their full potential.
- ii. APSI will strive to preserve the privileges of its members and enhance the standing of the Plastic surgery profession in the community
- iii. APSI will endeavor to create means of access to affordable quality care to all who need Plastic, Reconstructive and Aesthetic Surgical services in the country.
- iv. APSI will engage government, regulatory agencies, other sister organizations and medical education policy makers to achieve the above ideals.
- v. APSI endeavors to improve the public perception of Plastic surgery in the country and promote ethical and quality plastic surgery practice with the cooperation of the public.

#### 1.2 b) Areas of activities in which attention is to be given in next five years

#### i) Streamlining the administration of the APSI activities

a. APSI needs a permanent office. Currently the address is related to either a present or past office bearer, which leads to difficulties in the long run. The current scenario where legal and tax issues will hog any organization, having a permanent office will go a long way. Mumbai will be ideal as the APSI trust registration in the Charity commissioner's office in Mumbai, and the GST registration Priority status

#### Urgent within 1 year

Committee comprising of Dr Prabha Yadav, Dr. Vinita Puri, Mukund Thatte and Shailesh Ranade (member secretary) will look into it and give proposal by mid term executive.

The general body has approved it.

b. APSI needs a fulltime / Part time manager to look after day-to-day activities. The manager will work under the secretary to do all communications, web content management, maintenance of documents and helping the lawyers for running the court cases.

The manager will be present during each APSICON at allocated APSI lounge allowing to sort out many issues of members during conference days. The manager will also can attend important meetings and take notes so that we can have documentation and minutes of all the meetings held during the conference or the midterm executive committee meetings.

This is a priority as we have more than 1650 members now. Every year approximately we add 50-60 members, so will reach 2000 mark soon.

#### ii) Improving the public face of Plastic surgery and APSI

By increasing the public awareness about the wide spectrum of work we carry out, the client base of Plastic surgeons can be tremendously increased. This can be achieved by employing an advertising team. The ads created should be catering to the interests of every plastic surgeon in the country. These ads should create awareness about the need of trained Plastic surgeon expertise in varied clinical problems. Publicist can use social media such as Facebook and promoting posts for better visibility. News about significant plastic surgery should be featured from across the country. Invited articles to magazines and papers can also be used as an effective means. The same team will form the strategy for awareness programme every year on the eve of the National Plastic and Reconstructive Surgery day i.e. July 15<sup>th</sup> of every year. Each year the emphasis could be on two or three aspects of Plastic surgery.

#### **Education and training**

#### a. Improving Plastic Surgery Training in the country

I) Adopting the APSI curriculum to M.Ch./DNB Plastic Surgery Training Programme

The curriculum prepared by APSI is excellent and has to be adopted by all Universities. We can request all the HODs across the country to request their respective universities to push for implementing this curriculum. Association will officially communicate to MCI. Even if it is not legally binding all teaching units offering either DNB or M.Ch. should be encouraged to adopt training with this as the basis.

#### II) Rotation of trainees to other units during training

Each department has its strengths and weaknesses in the spectrum of activity the trainee are exposed. Rotation to other units has not been widely practiced due to the lack of support for this concept from the medical council. The trainee should be offered structured rotation between consortiums of units. For this the universities and medical council should be lobbied to make changes in the present laws governing such training.

#### III) Nationwide digital teaching network

All the Plastic Surgery units in teaching institutions can connect by Skype or similar virtual meeting facilities. The participating institutions will be doing their routine teaching programmes like case planning sessions, topic discussion and journal clubs televised. This can be viewed by any other center and trainees. The events will be notified by SMS to the members of this programme . The role of APSI (through one designated member of the training supervisory committee) will be to coordinate and make a time sheet for three months to be published in the APSI website. The new website is enabled to send email reminders to the members .

#### IV Restructuring APSI CMEs

The training supervisory subcommittee will design 10 courses. The committee will make the curriculum for these courses and identify faculty members. The committee's term will be of three years. The course will be run by a local leading Plastic surgeon. Funding of these courses need to be relooked. It is supported by Ethicon donation and APSICON 2005 donation. Hence it is to be named as APSI accreditation course ( supported by Ethicon and APSICON 2005 fund)

#### V Surgical skill enhancement programmes

For this we need to have 2to 4 cadaver dissection courses every year. These should be made mandatory for the trainees during their three year course. The cadaver courses can be arranged with participation of anatomy departments. APSI should work with Ethicon or other institutions for APSI endorsed micro vascular courses.

The AO course for maxillofacial trauma should be approached to be endorsed by APSI and made mandatory for the trainees once during the training period.

- International short term fellowships are beneficial to younger plastic surgeons in gaining expertise. There should be increase in number of these posts lasting 1-2 months. Each should carry a bursary of 2000 USD. Liaison work with overseas consultants as well as units should be initiated by the APSI to facilitate the placement of these trainees.
- ii. The scheme to encourage the international trainees to come to India started by the savings of APSICON 2012 fund is a laudable thing, which improves the profile of the Plastic surgery community of India in the international scene. The number can be increased Corpus needs to be augmented.

### V) Starting new APSI accredited training fellowships in novel areas of clinical practice

This is aimed at training the younger surgeons and empowering them to take up newer vistas in plastic surgery. They should be 6months to 1 year paid posts in units, which can partner with the APSI for this purpose. Eg. Cerebral Palsy, lymph edema surgery, onco plastic breast surgery. The OMFS society has such a society sponsored fellowship the admission to which is by an exam conducted during the national conference. This will need a fellowship salary of 30-40000 per month for six months to be paid by the APSI as well as identifying two to three units who could absorb them and/or finance them

#### VI) Restructuring of the current fellowships

There are numerous fellowships available, but mostly underutilized. The main reason is for the low amount attached to these fellowships, as the corpus is small. These should be amalgamated or restructured

The committee comprising of V Bhattacharya, Shailesh Ranade, Parag Sahasrabudhe, (member secretary) Rakesh Khazhanji and Subramania Iyer was approved by the GB.

#### iii) Indian Journal of Plastic surgery

There is a need for making our journal more internationally accepted both for readership and article submissions. IJPS currently is PubMed indexed, open access journal both online and print. The journal website receives approximately 20,000 hits every month. There is no impact factor awarded to the journal, The IJPS is financed essentially by the APSI journal corpus. Advertisement are managed by the editor to raise the funding

#### 1. Should we change names to shed the regional image?

Till date 711 journals have changed their names The notable plastic surgery journals include BJPS to JPRAS, Scandinavian to 'Journal of Plastic Surgery and Hand Surgery,' Canadian journal to 'Plastic surgery' Korean journal to 'Archives of plastic surgery'

The downside is only the impact factor. When the new journal starts the impact factor counting stats only in its third year. But this is not a real issue, as we do not have an impact factor.

#### 2. Should we have new publisher?

New publisher with more offers could be considered.

Publisher needs to provide better editorial assistance and some attractive features such as ahead of print online publication of the article, this will remove delay in publication and provides author early accessibility of the articles.

#### 3. Should we remain open access and should there be print version?

To remain open access is necessary at this stage to get more visibility, citation and getting impact factor. However it will come at a cost as the income is only from advertisements. Publishers are

interested in promoting the journal only if it is a paid access.

Print version is needed at present. But the videos and extra photos can be given as online supplements.

The GB approved formation of the committee comprising of the former editors of the journal Dr. Surajit, Dr Thatte and Dr Jagannathan with the present editor Dr Dinesh Kadam to look into it and give suggestions by midterm EC

#### iv) Improving relationship with sister specialties and organizations

Plastic surgeons have relationships with other specialists like maxillofacial surgeons, dermatologists, ophthalmologists, ENT surgeons and orthopedic

surgeons. These may be either conflicting or complimentary. In general the output of working together is better. On personal grounds the relationship is excellent. Unfortunately this becomes sour when Associations are concerned and often-bitter feelings arise (eg the issue with MFS). This is not healthy. Hence steps to improve the relationship should be made

- a) Have sessions by these respective associations by turn in the others national conference
- b) Institute respective association accredited training programmes in areas of conflict

Eg offer oral cancer surgical treatment fellowship to MFS by us reciprocated by maxillofacial trauma fellowship by MFS association to us. Surgical dermatology by us to dermatologists and cosmetic dermatology by them to us

#### v) International collaborations

The international visibility of our association is to be improved. There should be more liaisons between the national organizations of other countries as well as consortiums like ICOPLAST, WSRM etc. (strength comes from attendance and contribution in terms of participation and taking active membership roles. But lobbying should be done to make the membership payment to these societies affordable to ours. If needed we should add the agreed amount to the annual membership fee we are proposing) The activities that could be initiated include

> a) Organize APSI session by a team of faculty members in their national meeting. This team will travel and participate on their own, but may be partly supported by APSI in future when funds are available. This will allow us to show case our capabilities and achievements. (they say that we first need to put in registrations and free papers)

- b) Invite a team from another country's association each time for each of our national meeting. Offer them local hospitality and <u>free</u> registration The team can be three to four members. The APSI should subsidize the organizing committee for this gesture. It could be accommodated for 1-2 hrs in the CME section The can run a small plenary session or be included in the keynote/ oration slots
- c) Arrange mutual exchange programmesThe ASPS APSI summit is in the similar lines

This is to be planned and executed by a subcommittee called **Liaison subcommittee** of APSI The committee will talk to other associations, identify the partnering institutions and formulate the curriculum. In future the committee can have representative from all the concerned associations.

#### 1.2 c) Special issues that need attention and discussion

#### 1. Utilization of money generated in APSICON

APSICON is the main revenue generator for APSI. The current practice is that the organizing committee suggests how it should be utilized.

This takes away the freedom from APSI to utilize this amount in a more organized and a visionary way. Some of the funds from previous APSICON are still remaining unutilized. Hence all the funds should be at the disposal of APSI .The APSI will prepare a wish list out of which the organsing committee can choose which is more suitable for them. Each of these contributions will be noted with the tag of that APSICON.

The general body approved the proposal

#### 2. Request for further named orations/sessions and prizes in APSICON

The Plenary sessions are clogged now. Any further named sessions on the podium will greatly reduce the ability to formulate good scientific programme It takes away the time for accommodating good work and papers from India. Hence no further addition of named events that need podium time should be allowed. The request for named events is genuine and more and more requests may come in future.

Possible methods to satisfy these requests may be

- a- To combine a new name to a previously named event. Our lawyers opinion may be sought for clarity
- b- To replace some of the named events which don't have sentimental issues related to it.(Which may be difficult, as everything will have some sentiment attached)
- c- To use the method of prominent standees and projected materials of the person to be honored to be displayed all across APSICON avenues.
- d- To name halls after people
- e- To Name free paper sessions after people.

This could be an ideal solution when a particular session is named after the specialty of the person in whom it is instituted. (With a definite agreement that it shouldn't be a plenary session)

#### 3. <u>Requirements for new named events</u>

Any contribution should have a provision for inflation after ten years. If the people are not capable of doing so, it should be scrapped. The agreement between the sponsoring body and APSI must be explicit in this regard

Filing of Service Tax Returns for APSI was done biannually in stipulated time.

#### **TDS Refund received from Income Tax Department**

Treasurer's office was successful in getting TDS, worth Rs. 8, 36,980 for the Financial Year 2013-14, from Income Tax Department. The amount was transferred by Treasurer's Office to APSI Corpus Account.

Treasurer's Office received a request from Chairman APSICON 2013, for Refund of TDS Amount collected during the year 2013-14, for APSICON 2013. With permission of Executive Council guided by President APSI and Consent from Board of Trustees APSI, the sum of **Rs. 3,76,650**was transferred to APSICON 2013 Account by Treasurer's Office.

**APSICON 2015Surplus**From APSICON 2015, an amount of Rs 67,77,300 has been received, towards savings from APSICON 2015. As per APSI guidelines

- A. 10% would first go to the Journal corpus, i.e., Rs 6, 77, 730.
- B. 5 % will go to Buffer Fund: Rs. 3, 38, 865
- C. Chairperson, APSICON 2015 Organizing Committee DrPrabhaYadav, has proposed to utilize the funds from APSICON 2015 Surplus for creating APSI Office Premises. Treasurer's office

will work in close association with Secretary's office and Organizing Committee of APSICON 2015, to finalise the proposal.

#### **Grants from Ethicon**

Ethicon supports three PG CME Meetings with a Grant worth Rs. 5,00,000 each year. In addition Ethicon supports three Professorships and Travelling Fellowships, with a grant worth Rs. 1, 50,000. I sincerely thank Ethicon Division of Johnson & Johnson for their continued support.

#### **Journal Corpus**

We are now in a much better position to support our journal. We have increased our Journal Corpus from Rs. 56,20,000to Rs. 62,06,310 which will substantially help the Journal to become financially independent over next few years. In last one year journal corpus was increased by Rs. 5,86,310, thanks to successful APSICONs, 10 % of profit goes to Journal Corpus. In addition 5000 Rs from each life membership amount gets deposited in Journal Corpus.

Due to Non Utilization of Funds by Journal as well as few other grants APSI could not spend the required amount last year. As per information given by Executive Trustee, money required to be spent in this Financial year is about Rs. 37,00,000

#### **APSI Awards & Grants**

This year, all the awards were calculated at 7.5 % interest, as per instructions of Executive Trustee.

Hon. Secretary has requested for funds for upgradation of website. The process of Digitization of all APSI Documents from Secretary Treasurer and Trust is the need of the day. Upgradation of APSI Directory is in progress.

Executive Council has unanimously approved all three items. I seek the approval of General Body for the same.

The above three items were unanimously approved by the general body.

To avoid waste of Time and criminal waste of paper with additional expenses on postage & courier services, from last year, Treasurer's Office has started depositing award amounts of Awardees in their respective Bank Accounts directly by net banking from Treasurer's Account. Providing correct Bank Details will be entirely the responsibility of Awardee.

#### **Grant towards Short Notes in Plastic Surgery**

Dr. Ravin Thatte has requested for a grant worth Rs. 60,000 for his web based educational activity, "Short Notes in Plastic Surgery". APSI is supporting this activity for last five years. The members of Executive Council appreciated the work done by Dr. Ravin Thatte and assured a continued support worth Rs. 60,000 per year, till the time this activity is on, unanimously. Treasurer's Office seeks approval from General Body, for the same.

The General body approved unanimously, the proposal for continued support worth Rs. 60,000 per year for Short Notes in Plastic Surgery, till the time this activity is on.

Treasurer's Report was passed unanimously by all the members present in the General Body meeting.

#### 10. Trustee's report for the year 2015-16.

Dr Ahuja presented the accounts for the year ending 31<sup>st</sup> March 2016. The highlights of which were;

The Corpus of the trust was Rs. 5.495 Crores.

The additions during the FY 2015-16 were;

Dr. K S Shekar	Rs. 200,000/-
Life Members	Rs. 840,000/-
APSICON 2014	Rs. 930,795/-
APSICON 2015	Rs. 67,77,300/-

The utilization report of the Treasurer was found to be in order.

Dr Ahuja informed that in the current year all existing corpus over one year were augmented by 15% of the interest accrued, to be in line with tax regulations. All unawarded amount was considered as income and not merged with the Trust corpus.

All details of the balance sheet, corpus positions and investments were displayed by Dr Ahuja and they were approved. The entire amount with the Trust was invested and earmarked in designated corpus and there was hardly any unallocated amount now. He informed that the final amalgamated accounts of APSI had been duly submitted to income tax authorities and the charity commissioner, before 30<sup>th</sup> September, by the Treasurer.

Dr Ahuja informed that till so far an adhoc amount of Rs 30 lakhs had been provided to Treasurer for the year 2016-2017. All awards in the year 2016-2017 shall be made by calculating interest at 7.5%. Last year Rs 25 lakh had been provided to the Treasurer and he returned Rs 121,633.00 as unspent amount. The Treasurer also returned Rs 42,246.76 lying unspent with him from the previous year.

In the current year the Trust expects an income of Rs 44 Lakh and so it has been advised by CA that at least 38 lakhs needs to be spent on activities. It was discussed that we need to spend 85% of the interest accrued each year or there shall be a tax liability. This stipulation was reminded to the Executive committee by the Executive Trustee.

Dr Ahuja informed that the Treasurer was still working on the 'change of Trustee' report to be submitted to the charity commissioner. Since there was a new Trustee appointed last year the report to the Charity commissioned had to be filed again. As this matter has been pending, the assets in HDFC and UTI cannot be claimed or reinvested, nor were we getting any interest from these deposits. Dr. Ahuja mentioned that the investments in HDFC had matured > 5 years back and was a substantial amount but the Investments in UTI were small compared to the Trust corpus today. He had requested Dr Thatte to pursue the HDFC investments since the office was located at Mumbai. Dr Thatte would be able to do so once the Treasurer provides him with a copy of the change of Trustee report filed with the Charity commissioner.

Dr Ahuja informed that the bank accounts of the Trust were still located at Chennai and Mumbai, and he had to operate them through Dr Sridhar and the Treasurer, respectively. It was decided that the Canara Bank account should be moved to a branch in Delhi and gradually it could be closed after the money was transferred to the SBI account at Mumbai.

It was informed that Dr V Bhattacharya was completing his five year term as a Trustee. He was unanimously proposed for a second term. The Board of trustees are now

The general body approved the trustees report unanimously.

#### 7. Editor's report and accounts for 2015-16.

The IJPS is continuing to progress as any flagship journal should. There are large numbers of articles being submitted from overseas. It has now achieved the Emerging Scientific Citation Index, which is a big step forward, but still short of a Medline indexing. Citations are also improving.

We have entered into a new 1 year contract with Wolters Kluwer. Costs of printing and mailing have also gone up. Recently a website maintenance fee has also been added.

Visibility of the journal has also improved. Number of hits for each article has also gone up. We are also looking at possibility of sending hard copies by courier.

The system of review is undergoing a critical evaluation. Some glitches in the system need correction.

# 6. Secretary's report.

The secretary informed the general body that two E newsletters as mentioned above were published this year. The E newsletters were circulated to all the members by email individually. They were also published on the website of our association. The announcement for various awards of the association is published in April newsletter every year. The secretary informed that following will be dates for the next APSICON at Kochi.

He requested Dr. Iyer to present details about Kochi conference. Dr. Iyer showed a short video film about upcoming conference and informed that he will be the organizing chairman, Dr. Jose Tharayil will be the Treasurer and Dr. Sundeep Vijayaraghvan will be the organizing secretary,. He welcomed and appealed all the members to register for Kochi APSICON.

# **Dental Council issue**

The secretary informed that this issue about dental council encroaching upon our speciality was raised by Dr. Satish Bhat in the last GB meeting. A RTI was filed to Dental Council of India. The reply received was evasive saying that 'as per available records no information is available'. He informed that the dental council has now proposed to start MD Ch course in Maxillofacial Surgery. He informed that solution proposed by Dr. Satish Bhat after consultation with the lawyer is that APSI writes to MCI and MOHFW and in case we do not receive reply, then proceed legally. We might incur legal expenses if we proceed further and sanction from GB is sought for proceeding legally in order to safeguard the interest of our fraternity. He invited Dr. Satish Bhat to podium to address the GB about this issue.

Dr. Satish Bhat said that new proposed curriculum says that the MDS dentist perform grafts, flaps, radial forearm flaps, micro vascular anatomises, skull base surgery etc. which is gross violation of public safety taking into consideration lack of adequate training during MDS and BDS course. This new course proposed by dental council is being opposed by their own members. The proposed plan of action to be taken by APSI is already explained by the Hon. Secretary.

The Hon. Treasurer reminded the general body that if this resolution is passed, APSI will be filing a writ petition against dental council. The proposed fee as quoted for first 2 hearings is 1.5 to 2 Lakhs Rs. and may go up if higher council is required. The President said that we have some time as we will first write to MCI and MOHFW and wait for their reply.

Dr. Surajit Bhattacharya said that when clinical establishment act was introduced we at Lucknow opened an unofficial channel with the ministry of health and UP govt. and met Mr. Naddha so that we could explain them our stand. He asked whether we are going ahead only officially or unofficially as well. Dr. Karoon Agrawal said that your point is well taken and we will deliberate this in the midterm EC. Dr. Kalpesh Gajjiwala said that we have to send official communication so that it stays on the record. Dr. Satish Bhat requested that one more member should be with him to file a writ petition in case need arises. He suggested name of Dr. Medha Bhave. The General body approved the same.

# Resolved that Dr. Satish Bhat and Dr. Medha Bhave are authorised by APSI to proceed legally in case of dental council matter if the need arises under the guidance of the President and the Executive Council and legal expenses for the same will be paid by APSI.

Proposed by : Dr. Lokesh Kumar Seconded by: Dr. Surajit Bhattacharya.

The general Body passed the resolution unanimously.

Dr. Lokesh Kumar said that the association is working on yearly basis. We need to have strategic planning committee which can take a long term view for 10 years to look into the role of association in these matters. President Dr. Karoon Agrawal said that this is a very valid point and requested the secretary to make a note of it.

Dr. V. Bhattacharyya commented that in the past presidents meeting Dr. Karoon Agrawal the current president was given some suggestion which should have been included in the agenda of this meeting. Dr. Karoon Agrawal said that he never said this GB, because the agenda was already fixed. He said that he will send the suggestions to the secretary for discussion in midterm EC.

Dr. Raja Sabapathy said that we are talking about encroachment by other specialities into our field. Since there are lot of younger generation colleagues here I would like to suggest that we should be better than others. We need to get trained from maxillofacial surgeons if they are doing better job than us. There is no reason to fight. We cannot prevent ENT people from doing head and neck surgery. He suggested that APSI should hire a top class agency to propagate plastic surgery to masses. He reminded the general body that savings from his conference could be utilised for the same. He also requested Dr. Prabha Yadav madam to consider this while allocating savings from APSICON 2015.

Dr. Sundeep Vijayraghavan suggested that the candidates who are contesting for president's post should be given opportunity to present their thoughts on the podium before day of voting. The president Dr. Karoon Agrawal requested Dr. Iyer – next president to implement this in Kochi conference.

Dr. Arun kumar Choudhary said that what is the role of president- just meet once a year and have a conference. We should have some long term plan for presidents. Dr. Iyer said that this has been already suggested by Dr. Lokesh and we will work on this.

Dr. Mohit Sharma said that in the last GB resolution was passed saying that person who has won Peet prize will not be eligible to apply for next 3 years. This is unfair and injustice to the merit and good work. Dr. Raja Sabapathy agreed with the same. President Dr. Karoon Agrawal said that we cannot change resolutions every year. Let us give some time and we can review later. Dr. Lokesh kumar said that GB is supreme and one can move a resolution here if anyone wants to do so. Dr. Karoon Agrawal said that there is a procedure for the same that need to be followed.

Dr, Satish Bhat said that why can't we form a three member committee to plan long term course for APSI as suggested by Dr. Lokesh Kumar in this meeting itself. Dr. Iyer said that this matter needs deliberations and should not be handled hastily.

The secretary thanks the election officers Dr. Ramakrishna Nair and Dr. P.K. Bilwani for conducting the elections smoothly. He also thanked Dr. Yogi raj Handoo, Dr. Vinita Puri, Dr. Dinesh Kadam and Dr. Jiten Kulkarni for their help during the election process. He thanked the Hon. Treasurer Dr. Shailesh Ranade for his help for overlooking the entire elections.

He requested the Hon President Dr. Karoon Agrawal to announce the results. Dr. Karoon Agrawal called the election officers to the stage and announced the results which were as follows.

a) President - One (for 2017) - Dr. Iyer Subramania

b) Vice President - One (for 2017) - Dr. Surajit Bhattacharya

c) Executive members - Three (for 2017-19) – Dr. Arun Kumar Choudhary, Dr. Raj Mishra and Dr. V. K. Tiwari

The house applauded and congratulated the elected members.


