

adapted to the new types of jobs whereas the mediocre perished by the wayside. The 3rd industrial revolution was in front of our own eyes ushered by the computers, digital technology and the internet, and you know what happens if you are not friendly with them - you can't even communicate with your children and grand children! But friends, slowly without a big bang announcement, the 4th industrial revolution has arrived with ten technologies Autonomous robots, Simulation, Big data and Analytics, Augmented Reality, the Cloud, Cyber security, Additive manufacturing, Internet of things and Artificial Intelligence. A vast range of jobs are being disrupted and according to a McKinsky report 400-800 million jobs will be lost by 2030. Even scary is a World Economic Forum report which says 7.1 million jobs will disappear by 2020 and only 2.1 million new ones will be created. 47% of the current jobs in the U.S. 77% in China, 69% in India and 65% in Argentina are at risk and the health care industry is on the verge of cataclysmic changes. We can't even skill people for newer jobs because the technology required then hasn't been invented yet!

Once you take in this bigger picture you will realize how myopic specialities are getting today when they try to put an impregnable fence around themselves and get really angry when other specialities break into their insulation. The fact of the matter is we will not be able to hold on to anything as our own because we can either keep on innovating and improving or we risk becoming the tangawallas of tomorrow.

Friends, historically we have been in the forefront of innovations. We have innovated a technique, perfected it to the point of simplification and then others have taken over while we have progressed to meet newer challenges. Plastic Surgeon Joseph Edward Murry did the first successful kidney transplant on identical twins on December 23, 1954. Did we keep the skill only to ourselves? Aspad and Georgio Fischer did the first liposuction in mid 70s but within a few years dermatologists were doing this surgery in local anaesthesia. What was our response, we thought of utilizing the liposuction aspirate for fat grafting. A far cry from Vincent Czerny's attempt to transfer a lipoma from the gluteal region to the breast in 1895, Mel Bircoll used the liposuction fat for breast augmentation in 1987, Roger Khouri improved the results in 1999 using the Brava, Sydney Coleman in 2001 taught us the structure of fat grafts and how to achieve maximal take, Scott Spear used fat graft as an adjunct to other modalities of breast reconstruction in 2005 and Gino Rigotte showed us the regenerative potential of adipocyte derived stem cells in 2010. These plastic surgeons did not complain that somebody else has stolen their chocolate; they just went on improving their chocolate, adding fruit and nut and almond and pistachio and rum to make it more lucrative. That is what we are programmed to do, we innovate and we improve.

We picked up microsurgery from a Swedish ENT surgeon Carl Olf Siggensen Nylun and on May 23, 1962 Ronald Malt did the first limb replant. Almost a decade later in 1991 Taylor and Daniel did the first free tissue transfer and on January 14, 1999 the Klinert Kutz Hand Care surgeons did the first composite tissue allotransplantation, a hand transplant! Today microsurgery is being practiced by so many other specialities but we still remain the ones who are innovating and doing face transplant and abdominal wall transplant.

We learned to do hair transplant from Norman Orentreich, a New York dermatologist in 1950, but by our skills we have perfected it to an art form and today we have discovered stem cells and dermal papilla cells and we are attempting hair multiplication and hair cloning, which will be the future of this surgery.

We Plastic Surgeons are uniquely placed to make a natural progression from reconstructive to rejuvenative to regenerative surgery. We have learned to get 3D printed shapes of extra-cellular matrix. We have seeded them with live cells too and made human pinna and nose shapes on experimental rats and pancreatic tissue and cardiac muscle syncitium on patery dish. It is only a matter of time when we will prefabficate a tissue expanded adipofascial platform on the radial forearm or ALT territory, 3D print on its surface a designed extracellular matrix, seed it with cardiac myocytes and grow a sheet of beating myocardium. We can then wrap it around a failing heart as a free flap and anastomose its pedicle to the coronary vessels. The same platform can be used to grow a pancreatic or a thyroid cell line and we can add a microchip which will read the serum insulin or thyroxine levels and send graduated amounts of these hormones in circulation.

Friends, inter-disciplinary cross linkages should be developed and far from insulating ourselves, we should learn to use each other's data and expertise. Prosthetics and Plastic Surgery can come together with Artificial Intelligence and create a bionic arm. The world has seen through a bionic eye and held objects with a bionic arm, so a bionic man cannot be

very far away! You think that is not possible. Don't bet on it. The future has a habit of arriving faster than we think. It was in 1959 that while conceiving the idea of Asterix and Obelix in the famous comic series writer René Goscinny and illustrator Albert Uderzo presented a character called Getafix who would use his magic potion to reattach the fallen limbs of the Gaul soldiers fighting the Romans and in just 3 years in 1962 Ronald Malt did the first limb replant! And today it is happening regularly in a hospital near you.

Who knows, one day being and machine may merge, body and consciousness may be rewired. The new combination of the natural and the artificial, the hardware and the software will create mechanical humans or human machines. Artificial parts will be used increasingly to replace diseased parts, secrets of health will be decoded and who knows, death may become optional! And we, the Plastic Surgeons will be in the forefront of this revolution!

Thank you for electing me to preside over the affairs of the Association. Throughout the year I had the good fortune of visiting several State Association meetings and Regional meetings and was awe struck by the quality of work being done by our junior colleagues and the excellent leadership that is being offered by unsung heroes and heroines of our specialty! By their combined effort we are destined to be the frontrunners of tomorrow!

# Concluded Conferences

## **Midterm CME of MAPS**



Maharashtra Association of Plastic Surgeons (MAPS) organised a one day midterm CME in collaboration with AAPS (A new association of aesthetic plastic surgeons from Thane, Mumbai and Navi Mumbai) on 9th September 2018 at Thane. The CME was focussed on advances in body contouring and fat grafting which is upcoming novel concept which has found application in various folds of plastic surgery.

The CME was inaugurated by respected Dr. R L Thatte who spoke about need of fat grafting results to be critically evaluated. He also emphasised need of incorporation of more and more competent lady professionals in practice. Dr Swaran Arora elaborated on how fat grafting and body contouring is getting refined and deliberated on aging and death likely to be optional in near future due to better understanding of genes and telomeres. Dr Surajit Bhattacharya, APSI President, stirred many minds by alluding to instant gratification monkey that prevents one from doing arduous tasks like writing a scientific paper.

Delegates were instantly in introspection mode. It was for the first time that stalwart of medicolegal arena Dr. Lalit Kapoor addressed a plastic surgery forum on medicolegal aspects of cosmetic surgery. He suggested need to weed out unqualified people projecting themselves as cosmetic surgeons.

The chieffaculty Dr. James Roy Kanjoor (Coimbatore),





Dr. Sandeep Sharma (Baroda) and Dr. Milind Wagh (Mumbai) discussed techniques, indications and application of fat grafting in various branches of plastic surgery—be it aesthetic or reconstructive. The impact brought about by fat graft on implants and fillers as well as complications were covered. Other speakers extensively covered research aspects of fat grafting and advanced body contouring such as after massive weight loss, drainless abdominoplasty, changed norms of upper body aesthetics, complications in abdominoplasty and breast reductions.

Few unique points about the CME were - A special session by younger plastic surgeons who had visited abroad to relate their experiences, a panel discussion to cover full program so that other faculty apart from speaker could contribute their experiences and opinions.

The team led by Dr. Medha Bhave included Drs Sameer Karkhanis, Venkateshwaran, Ajay Hariani, Nageshwari, Amit, Vikaskumar, Mithilesh and Sarfraz was appreciated for excellent team spirit and a good organisation. The CME was attended by 130 delegates from Maharashtra and outside; not counting faculty and guests which is unprecedented for a midterm CME. It included many past and present office bearers of APSI, MAPS, IAAPS and AAPS.

## 53rd Annual Conference of Association of Plastic Surgeons of India

21st-25th November, 2018, Lucknow, Uttar Pradesh.

## **A REVIEW**



The 53rdAnnual Conference of Association of Plastic Surgeons of India was organized in Golden Blossom Imperial Resort in Lucknow with the theme 'INNOVATE to excel, RESEARCH to lead and PROPAGATE to prosper'. The conference started with an APSI accredited course on Cleft lip & Palate and Craniofacial Anomalies on November 19 and 20, 2018 and this was held in the historic Brown Hall of King George's Medical University.All aspects of cleft care from embryology, prenatal diagnosis to protruding premaxilla, pre-surgical orthodontics, surgery, velo-pharyngeal incompetence, speech therapy, orthognathic surgery, post surgical orthodontics, surgery for secondary deformities and genetics were all discussed in great details. Prof. Arun Kumar Singh was the course convener and it was attended by 73 delegates.

The 1½ days Cleft course was followed by a 5 hours marathon session, Prof. K. S. Gloria Residents Forum in which 30 residents presented their research for three exiting book prizes. This was a unique opportunity for the residents to exhibit some outstanding work and learn from the masters the skills of podium presentation from the masters including editorial board members of IJPS, Indian Journal of Burns and Journal of Cleft Lip, Palate and Craniofacial Anomalies. Judged by a team of 5 experts on quality of research, novelty, type of presentation, quality of audiovisual aids used and ability to deal with questions, this was easily the best homage we could pay to a great teacher Prof. K.S. Goleria!

Prof. C. R. Sunderarajan Video workshop which followed on November 21, 2018 had video presentations in two halls and videos on Microsurgery, Oncoplastic Surgery, Paediatric Plastic Surgery, Aesthetic surgery, Burns, Hand Surgery, Uroplastic, Non surgical energy devices and Cleft & Craniofacial surgery were presented. Each section was assigned a convener well in advance and he in turn chose the videos for presentation. The videos were shown in 3 halls simultaneously and each session went on for 2 to 4 hours with ample opportunity for consultation with the operating surgeon.



Prof. Charles Pinto C.M.E was held on November 22, 2018. It was inaugurated by two legendary teachers of Plastic Surgery Prof. David David and Prof. Ravin Thatte. The former retired as the Director of the Australian Craniofacial Unit in Adelaide and the latter as the Head of the Department of Plastic Surgery in Lokmanya Tilak Municipal General Hospital in Mumbai. The team of Surgeons who successfully separated the craniopagus twins in All India Institute of Medical Sciences, New Delhi, Prof. Deepak Gupta, Prof. Manish Singhal and Dr. S. Raja Sabapathy presented their experience to a mesmerized audience. Interesting topics like Synergistic Infections, Hyperbaric Oxygen Therapy, Tissue expansion, Facial reanimation, Compression neuropathy, Distal nerve transfer, Aging face, Reduction mammoplasty, Ethics and Innovations at crossroads, Gender dysphoria and Transsexualism and Body contouring after bariatric surgery were also discussed threadbare.

The conference proper followed on November 23 to 25, 2018. It was inaugurated on the evening of November 22, 2018 by our most respected teacher Prof. R.P. Sahi. The Vice Chancellor of King George Medical University and my dear friend Prof. Madn Lal Bhatt was the Guest of Honour. Speaking on the occasion the President while cautioning the delegates about the cataclysmic changes facing the speciality opined that we will not be able to hold on to any procedure as our own and the only way to remain relevant is to innovate and to excel. The third volume of Text Book of Plastic Reconstructive and Aesthetic Surgery edited by Prof. Karoon Agarwal and yours truly was released on this occasion as was Dr. Madan Kapre and Sudhanshu Kothe book on Oral Submucous Fibrosis. Dr. Venkat Ratnam's pocket instrument set was also released on this occasion.

The activities of APSICON 2018 were spread in six halls and each hall had the name of a Plastic Surgery stalwart. Not only this but every free paper session had the name of a living legend or a stalwart of yesteryear.9 masterclasses on Micro anastomosis, Eye lid reconstruction, Facial rejuvenation, Brachial plexus injury, Tissue expansion, Jaw reconstruction, Fingertip injuries, Rhinoplasty, Hair restoration and two hands on workshops on Venous coupler micro-anastomosis and Osteotomies in Orthognathic Surgery were arranged during the conference.

The plenary sessions were very interesting. The Gillie's Oration was delivered by Prof. Karoon Agarwal and the highlight of which was his experiences as the editor in chief of the Text Book of Plastic Reconstructive and Aesthetic Surgery. Godrej Oration was delivered by Prof. David J, David and he spoke about his journey of cranio-facial surgery regarding delivery of healthcare to cranio-facially deformed children. Prof. Georgia de Santis was the Sushruta Orator and he spoke about his innovative use of the free fibula for maxillary and mandibular reconstruction. Prof. Murari Mohan Mukherjee Oration was delivered by Dr. Rakesh Khazanchi, Prof. A.C. Ganguli lecture by Dr. ArunGosain, Prof CBK Oration by Dr. S K Soni, and Dr. S.N. Sharma Endowment lecture by Dr. Wolfgang Huber.



Two features one old and one new became the highlights of APSICON 2018 were the Prof. S.K. Bhatnagar Quiz competition and Dr. Ashok Raj Kaul Innovation Forum. The Quiz had a preliminary round from which 4 teams of two were chosen for the finals which was held in front of a full house. Dr. Rajesh Powar and Dr. Sheeja Rajan TM conducted the Quiz and the certificates were given away by Dr. Mrs. Archana Bhatnagar, wife of Prof. Bhatnagar, who most kindly graced the occasion.

The progress of surgery has been utterly dependent on continuing innovations by surgeon innovators, largely because surgeons work in an environment that is very conducive to innovating. Of all clinicians surgeons excel at improvisations and innovations. Innovation makes plastic surgery different and distinctive, and whenever we think of innovations the name that comes to our mind is that of our departed friend Ashok Raj Kaul! APSICON 2018 dedicated two sessions of 45 minutes on Innovations to celebrate his association with us. The competitive section on Day 1, moderated expertly by Dr. Subodh Kumar Singh, had 15 papers and the non-competitive section on Day 3 another 16 paper and there were three book prized for both the sessions. The Organizing Committee is profoundly indebted to Dr. Asha Kaul, wife of Dr. Ashok Raj Kaul and her daughter, who came all the way from Bangalore and chose to grace the occasion.

Prof. R.N. Sharma Memorial Symposium was on 'New Age Prosthetics' and it was moderated by Dr. Rakesh Khazanchi. Peet prize session had 3 papers competing for the award and APSI Best Paper Award session had 10 entries. Dr. S. Raja Sabapathy gave a very thought provoking lecture on 'Where is our speciality going?' which had high dose of optimism and a shining outlook for future.

We thank the delegates of APSICON 2018 for the overwhelming response to our call for scientific papers. The scientific sessions could be just as good as they wanted them to be, and they did a wonderful job! We thank the regional coordinators and state associations for suggesting the names of their extraordinary performers for 'straight to the podium' route. They had excelled at the state/regional levels and now they dazzled in National limelight! We thank the APSI Scientific Committee for doing a blind review and painstakingly evaluating each abstract and marking them in five categories. Their marks were tabulated by the local scientific committee to finalize the final set of papers which made to the podium in the free paper sessions. Thus a conscious effort made by the scientific committee to project maximum number of new faces on the podium. As these papers came through a grueling process of selection we felt that every free paper session should have a book prize and the Chairpersons of the session were given the responsibility to decide the most promising paper of their session.

All those abstracts which did not score enough to make it to the podium were seen in the Prof. J.L. Gupta E-paper session. Delegates had enough time to view these E-papers on computer terminals and mark them in the APSICON app by using their







cell phones. First 5 E-papers, chosen by all delegates, were presented in front of the judges and Prof. J.L. Gupta E-paper Awards were decided. Similarly the posters which did not make the mark for the Kamath Poster Award competed for Prof. B.M. Daver Best Poster Awards. Each of these sections had 3 book prizes and these were awarded in the Valedictory Function. All the sessions which had names of the stalwarts had certificates with a photograph of the respective stalwart. Prizes mean different things to different people. To a junior colleague prizes are like motivation that inspires him/her to keep doing the good work and propel forward in life. For the seniors perhaps prizes do not matter much for they are self motivated individuals who know that their not getting one cannot bring down their stature. However, recognition from our peers at any stage of professional life, feels good.

U.P. Medical Council was gracious enough to grant 20 Credit hours to the delegates of APSICON 2018 and 8 extra credit hours for the APSI Accreditation Course on Cleft Lip & Palate (Reference No. UPMC/10375/18 Dated 12/11/2018.

The social evenings were very thoughtfully planned. Plastic Surgeons showed their talent in the Karaoke night on November 21 and an Awadhi night with Gazals, Katthak and Mujra was organized on November 22.

A very well planned APSICON Premier League limited over cricket match between the President's XI and Vice President's XI was held on November 23 with all the musical extravaganza, dances, cheerleaders, fireworks and fire jugglery.

The last evening had a Bollywood hue with old melodies from the golden era and racy dancing numbers of recent times for people to dance on Dr. Murugesan Dance Floor.

The trade exhibition was held in Dr. P. K. Bilwani trade zone and was very well attended. The participants did brisk business. The newly released Text Book of Plastic Reconstructive and Aesthetic Surgery sold 150 copies in 3 days!

The Organizing Committee was overwhelmed by the generous appreciation of their efforts to make APSICON 2018 informative, educational and enjoyable. The delegates came from faraway places, spent their time, energy, money and efforts to be with us. #### **1. NEW WEBSITE**



There is a Complaint filed in Mumbai Charity Commissioners' office against the Trustees and the association. The Secretary and Executive Trustee have travelled to Mumbai on several occasions to meet Lawyers and to submit necessary documents towards inquiry notice received by the association.

There was an email enquiry from Office of Assistant commissioner of Police from Delhi regarding complaint against the association which was replied to by the secretarial office.

All these above matters involved lot of paper work and tremendous man hours were spent in coordinating between our lawyers (different for both the cases) under the wise guidance from Trustees and Presidents from time to time.

Thus, Treasurer's Office is not in a position to pay the Professorship and Fellowship amounts to the awardees since last year. Hon. Secretary is making efforts to get the above funds at the earliest. No PG CME Course is being held this year with APSICON 2017. Treasurer has received Funds from Ethicon for next PG CME Course.

#### **Journal Corpus**

We have increased our Journal Corpus to Rs. 71,66,580 which will substantially help the Journal to become financially independent over next few years. In last two years journal corpus was increased by more than Rs. 15 lakhs, thanks to successful APSICONs, 10 % of profit goes to Journal Corpus. In addition 5000 Rs from each life membership amount gets deposited in Journal Corpus. Now Journal gets an interest worth Rs. 4 - 4.5 lakhs approximately each year.

Treasurer's Office has urged the Editor APSI to utilise the funds allocated to the Journal in same Financial Year.

As we have been able to create a significant corpus for the journal in last five years, EC has proposed following change for addition in Journal Corpus.

- 1.5% of APSICON savings
- 2. Rs. 2,500 from Life Membership Fee of each member.

#### I seek GB's opinion on this matter.

There was a detailed discussion about Journal Corpus amongst the members. It was decided that status quo should be maintained for one more year. The Journal Corpus and its utilization should be reviewed in next GB Meeting, so that appropriate decision can be taken.

#### Budget for the year 2017-18

Executive Trustee APSI has informed Treasurer's Office that available interest to be spent in this financial year is Rs. 38 to 40 lakhs. Accordingly the Budget for the financial year 2017-18 worth Rs. 39, 36, 086.17 was presented by Treasurer APSI.

The Budget was approved unanimously by all the members of the General Body.

# General Body has unanimously approved following projects last year, which are expected to be completed before next GB Meeting.

- 1. Upgradation of website
- 2. Digitization of APSI Documents from Office of Secretary, Treasurer & Executive Trustee
- 3. Upgradation of APSI Directory and its publication

#### **New APSI Website Expenses**

Till now APSI has paid Rs. 1, 10,750 towards new APSI Website. Approximately additional Rs. 60,000 will be required for the total expenses for the new website.

#### Legal Expenses

Wadia Ghandy & Co. was paid Rs. 4, 98, 990, towards Legal Expenses for appearing for a court case and representing APSI in a Civil Suit filed by Dr. Ashok Gupta.

The Legal fees for representing APSI against complaint filed by Dr Ashok Gupta in Charity Commissioner's Office in addition to Legal Expenses for Civil Suit for this year are not known. Hon. Treasurer has made provisions worth Rs. 8 lakhs for the same in the Budget.

#### Awards & Grants for the Year 2017

This year all Awards & Grants are given with interest rate on corpus calculated at 6 % as per instructions of Executive Trustee. To avoid waste of Time and criminal waste of paper with additional expenses on postage & Courier services, since last two years, Treasurer's Office has started depositing award amounts of Awardees in their respective Bank Accounts directly by net banking from Treasurer's Account. Providing correct Bank Details will be entirely the responsibility of Awardee.

#### **Grant towards Short Notes in Plastic Surgery**

Dr Ravin Thatte has requested for a grant worth Rs. 60,000 per year for his web based educational activity, "Short Notes in Plastic Surgery". APSI is supporting this activity for last six years. General Body has already unanimously approved this Grant worth Rs. 60,000 till the activity is on, last year. EC has appreciated the work done by Dr Ravin Thatte and assured a continued support worth Rs. 60,000 per year, till the time this activity is on, unanimously. I seek approval of GB.*The members of GB appreciated the work done by Dr Ravin Thatte and, unanimously approved the grant.* 

#### **Transfer of Interest generated from MAPSI Corpus to MAPS**

Interest generated from following funds from MAPSI worth Rs. 56, 758 will be transferred to MAPS.

- 1. Promotion of Scientific Activity Plastic Surgery Mumbai Fund: 14,189.58
- 2. Promotion of Scientific & Educational Program Maharashtra Chapter: 14,806.32
- 3. Maharashtra Chapter Office Premises Fund: 27,761.70

#### **APSICON 2013 Bank Account**

As per the General Body Resolution, Hon. Secretary was successful in closing the Bank Account of APSICON 2013, held in HDFC Bank, Mumbai. Treasurer's Office has received a Demand Draft worth Rs. 4,071.77 in the name of APSICON 2013, towards closing balance from APSICON 2013 Account. Treasurer's Office has been advised by EC as well as Executive Trustee that DD received by Treasurer's Office should be preserved, without taking any further action on it. I require GBs approval for the same. A word of appreciation is specially required for extraordinary efforts taken by Hon. Secretary APSI.

All the members of GB appreciated the efforts taken by Hon. Secretary APSI. Members of GB unanimously agreed that the DD received by Treasurer's Office should be preserved, without taking any further action on it.

#### GST

Treasurer's Office has taken an advice from APSI GST Consultant regarding application of GST in case of APSI.

According to APSI GST Consultant,

1. The APSI Membership Fees are liable for GST under SAC Code: 9995 (Services of membership Organisations) and rate applicable will be CGST 9%, SGST 9% or IGST 18%

2. Conference Registration Fees are liable for GST and rate applicable will be CGST 9%, SGST 9 % or IGST 18%

3. For Accommodation Advance collected on behalf of the Hotel, No GST will be charged if accommodation advance is collected and paid directly in the account of Hotel.

4. For Sponsorships it would be subject to Reverse Charge Mechanism. Hence GST needs to be paid by Sponsorer and not by APSI.

5. Can we function with one GST No. we have?

We can charge IGST, for out of Maharashtra state transactions, since the billing would be from Mumbai. However we have to ensure that the amount is properly collected. Further on the Purchases or Services bills, like hotel and other services taken in that state, Tax of respective State is applied then we would not be able to take the credit for the same. Hence we need to ensure that Vendor/ Supplier bills are not charged to Respective State.

There was a detailed discussion of GST Application amongst the members of EXCO Including APSI Membership Fees. Advice given by APSI GST Consultant as well as other consultants was considered. In view of lack of clarity about GST, it was unanimously decided by EC that we will hold on with GST Payment towards membership fees, for new members of APSI, for now. APSI EC will take appropriate decision, as soon as regulations are clear. I request GB to permit EC to take an appropriate decision at the right moment.

*Members of GB unanimously approved the decisions taken by EC related to GST.* **APSI Office** 

For the last six years, Treasurer's Office is the Official APSI Address. I am finishing my term this year. In view of APSI being registered as Trust in Mumbai, with Offices of Charity Commissioner and Income Tax Departments are placed in Mumbai, it is advisable to have a permanent APSI Office in Mumbai. Treasurer's Office, Secretary's Office and Executive Trustee have boxes full of documents which require to be preserved at one place. As per wishes of Organising Committee of APSICON 2015, the APSICON 2015 Corpus should be used for having APSI Office in Mumbai. We also have funds from APSICON 2010 Corpus & from MAPS Corpus which can be added to APSICON 2015 Corpus for this purpose. APSI should proceed with this Project at the earliest.

After the detailed discussion amongst the members of GB, it was decided to form a committee consisting of Dr Prabha Yadav, Dr Mukund Thatte, Dr Vinita Puri and Dr Shailesh Ranade (Member Secretary), to look into various options (on rent / outright purchase) for APSI Office in Mumbai. The amount worth Rs 5, 00,000 was approved for this year, in case appropriate place was available on hire for the same.

#### **Payment of Income Tax Dues**

Treasurer's Office has cleared the dues against various TAN accounts of APSI.

#### Audited Accounts of Midterm APSI Ethicon PG CME held at Pune and Bengaluru

Audited Accounts of APSI Ethicon PG CME, Pune were submitted by Convener; Dr. G. Vishwanath. Surplus worth Rs. 1784 was transferred to APSI. Audited Accounts of APSI Ethicon PG CME, Bengaluru are awaited and will be submitted on behalf of Convener, Late Dr. Ashok Koul in due course of time.

#### Approval of Change Reports by Charity Commissioner's Office

I am happy to inform all the members of APSI, that 6 Change Reports for Change in Trustees from 1993 till 2018 & Change Report of Change in Address of APSI have been approved by Charity Commissioner's Office. The change report for Change in name of 6 Trustee from Dr J K Sinha to Dr Mukunda Reddy is submitted to Charity Commissioner's Office for approval.

#### Verdict of Complaint filed by Chairman APSICON 2013 against an Independent Auditor

Chairman, APSICON 2013 had filed a complaint in Institute of Chartered Accountants of India against an Independent Auditor who was appointed to do re-accounting of APSICON 2013 Accounts. Multiple allegations were made in the complaint filed by Chairman APSICON 2013, including unethical conduct, submission of incomplete report, colluding in a criminal conspiracy, disrespecting ethical guidelines, violation of fundamental principles of Independent Auditor, circulating APSICON 2013 Accounts report to members of third party namely APSI Executive Trustee, President, Secretary & Treasurer, violation of ethics of Institute of Chartered Accountants of India, causing personal prejudice, loss of professional honours, character assassination, defamation, mental distress, conspiracy with malafied intentions.

The independent auditor has sent documents of the verdict given by Institute of Chartered Accountants of India, to Treasurer's Office for information, which state that The Respondent *(Independent Auditor)* is Not Guilty of Professional Misconduct and the complaint stands closed.

#### **APSI Delhi Chapter Bank Account**

From audited statements filed by APSI Delhi Chapter for last 6 years, APSI Auditor has noticed that APSI Delhi Chapter Bank account is dormant with no transactions occurring in this Account for more than 6 years, except payment of Audit Fees. Each Year audited accounts have to be amalgamated with APSI Account.

Now, each month we will require to file GST returns for each Bank account of APSI including APSI Delhi Chapter Account, even if it is a NIL return.

APSI Auditor has given following recommendations about APSI Delhi Chapter Bank Account: As there are No transactions / operations / Activities in APSI Delhi Chapter Account, thus it should be closed. Treasurer's Office is aware of the sentiments of many senior respected members including Trustees and past presidents belonging to Delhi attached with APSI Delhi Chapter. But closing of Bank account will not anyway disturb the activities of APSI Delhi Chapter and it can continue its activities with the same name. All other chapters have closed their Bank accounts opened with APSI PAN Card. The Executive Council unanimously agreed to request APSI Delhi chapter to close the bank account held with APSI PAN Card. I request guidance from GB about the same.

There was a detailed discussion amongst the members of GB. It was proposed that Treasurer APSI should write to office bearers of APSI Delhi Chapter requesting them to close the Bank account held by APSI Delhi Chapter on PAN Card of APSI. With Consent from Executive Council, following resolutions are placed in front of General Body for its Approval.

#### **Appointment of Auditors**

"Resolved that M/s SSNM & Associates, Chartered Accountants are hereby appointed as Statutory Auditors of Association of Plastic Surgeons of India for the financial year 2017 – 2018. One of the Trustees and Treasurer are hereby authorized to fix their remuneration."

#### Authorization to Treasurer

"Resolved that, Treasurer APSI, be and is hereby authorized to sign the financial statements along with one Trustee. It is further resolved that Treasurer APSI, be and is hereby authorized to represent the trust in case of representations to Income Tax Department, Charity Commissioner's Office and any other Statutory Authorities on behalf of trust."

#### Authorization for filing Income Tax Returns for next Financial Year

Treasurer's Office will be amalgamating the audited accounts of APSI and submitting it to Income tax department as well as Charity Commissioner's Office, before 30th September 2018. Treasurer will be circulating the audited accounts by email to all APSI Members and seeking their approval, before submission. I require a permission from the members to do so.

"Resolved that Treasurer APSI, be and is hereby authorized to file the returns to Income Tax Department & Charity Commissioner's Office, before 30th September 2018".

#### Authorisation for Opening and Operating Bank Account

"Resolved that the following members are hereby authorized to open and operate Bank Account in the name and style "APSICON – (YEAR)" under the name of the trust. It is further resolved that the PAN and Address of APSI shall be used for opening such new account."

"It is further resolved that the Bank account such opened shall be closed after conclusion of such event within a reasonable period of time preferably before the end of financial year, as decided by the Governing Council from time to time."

"It is further resolved that the Financial Statements of such event shall be prepared each year end, as at 31st March each year and a Audited copy of such financial statements, duly signed by all the office bearers of such event and statutory auditors appointed for that purpose shall be submitted before 15th May each year to the Hon. Treasurer."

#### General Body approved all resolutions unanimously.

Dear Members of APSI, I am finishing my second term of three years as your Treasurer. During my tenure, I always worked under instructions from President and Executive Trustee APSI. I have performed my duties with utmost sincerity and transparently. I have taken all decisions in best interest of APSI. Please forgive me if I fell short in my duties.

I wish to thank my Teacher Dr Ravin Thatte for guiding me. I wish to thank Dr Mukund Thatte and Dr K Sridhar, who were instrumental in making me a Treasurer and inspired and supported me for six long years. I have fond memories of my association with Late Dr K. S. Goleria, Late Dr B M Daver, Late Dr Narendra Pandya & Dr J.R.Jaju, Past Trustees of APSI, who helped me in streamlining the APSI Trust work.

I had a privilege to work with Dr Arunkumar Singh (President APSI 2012), Dr Ashok Kumar Gupta, (President APSI 2013), Dr Rameshkumar Sharma, (President APSI 2014), Dr Prabha Yadav, (President APSI 2015), Dr Karoon Agrawal (President APSI 2016) & Dr Subramania Iyer, (President APSI 2017). I am thankful to each one of them for their guidance and support. I wish to thank Dr Lokesh Kumar, Treasurer APSI (2006-2011), Dr Atulkumar Shah, Secretary APSI (2010-2015) and Dr Parag Sahasrabudhe, Hon. Secretary APSI, for their help. I wish to specially thank Dr. Rajeev Ahuja, Executive Trustee, for his help, constant support and guidance. I thank all the members of the Board of Trustees & Executive Council for last six years for their constant support.

Most importantly, I wish to thank all members of APSI for your constant support and encouragement. I will be your Treasurer till end of this financial year, i.e. till 31st March 2018. I congratulate Dr Sameek Bhattacharya, our next Treasurer APSI, welcome him to Executive Council of APSI, assure him full support and wish him all the very best for his tenure as a Treasurer. Thank you ladies and gentlemen for patient hearing.

Treasurer's report was approved unanimously by all the members of Executive Council

Treasurer's Report was passed unanimously by all the members present in the General Body meeting.

The secretary informed that in order to achieve smooth transition of Treasurers account Dr. Shailesh Ranade's name was proposed and accepted by EC to be coopted as member of executive council for period of one more year.

#### Resolved that Dr. Shailesh Ranade be co opted as member of executive council for one more year.

Proposed by: Dr. Parag Sahasrabudhe Seconded By: Dr. Surajit Bhattacharya.

#### 10. Trustee's report for the year 2016-17.

Dr Ahuja presented the accounts for the year ending 31<sup>st</sup> March 2017.

The highlights of which were;

The Corpus of the trust was Rs. 5.683 Crores.

The additions during the FY 2015-16 were;

New Life Members Rs. 12,30000/-

No savings were received from APSICON 2016 till 31<sup>st</sup> October 2017 but have been received recently of approx. Rs.30 lakhs .

The utilization report of the Treasurer was discussed and found to be in order.

Dr Ahuja informed that in the current year again all existing corpus over one year were augmented by 15% of the interest accrued, to be in line with tax regulations. All un awarded amount was considered as income and not merged with the Trust corpus.

All details of the balance sheet, corpus positions and investments were displayed by Dr Ahuja and they were approved. The entire amount with the Trust was invested and earmarked in designated corpus and there was hardly any unallocated amount now. He informed that the final amalgamated accounts of APSI had been duly submitted to income tax authorities and the charity commissioner, before 30<sup>th</sup> September 2017, by the Treasurer.

Dr. Ahuja informed that the Treasurer had received Rs 13,77,165.00 as TDS refund for the past years. From this amount Rs 3,76,650.00 was refunded back to APSICON 2013 account as the same was from that account and the APSICON 2013 account had reflected net deficit in accounting. Dr. Ahuja also informed that the APSICON 2013 Chairman had withdrawn all the balance amount in the account and only approximately Rs 4000 was left in the account as balance. This account was then closed with the efforts of the Secretary and a cheque was received from the bank for the balance amount which couldn't be encashed as it was in favour of APSICON 2013.

Dr Ahuja informed that till so far, an adhoc amount of Rs 25 lakhs had been provided to Treasurer for the year 2017-2018. All awards in the year 2017-2018 shall be made by calculating interest at 6% only as the interest rates had fallen drastically and the interest being received on our deposits was only 6.25%.

In the current year the Trust expects an income of Rs 41-42 Lakh (calculated @ average 6.25% rate of return) and so it has been advised by CA that atleast 34-35 lakhs needs to be spent on activities. It was discussed that we need to spend 85% of the interest accrued each year or there shall be a tax liability. This stipulation would be reminded to the Executive committee by the Executive Trustee.

Dr. Ahuja informed that the Treasurer had submitted the 'change of Trustee' report to the charity commissioner for all the pending years. Dr. Ranade informed that now the 'Change of Trustee Report' was filed till 2018 and only the inclusion of Dr. Mukund Reddy was to be accepted by Charity Commissioner following the retirement of Dr. J K Sinha. These stamped and attested 'Change of Trustee' documents from the office of the charity commissioner were submitted to the HDFC by Dr. Mukund Thatte and the locked FDs, since 2011, were renewed with interest, for a further period of 40 months from Nov 2016.

DR Ahuja informed that similarly an amount of 2.4 lakhs or so was lying locked in UTI for many years (invested since 1994) and the same procedure was required to get it released. It was suggested that this amount being small may be written off as the process to get them released was extremely tedious. An attempt shall be made once to get these certificates redeemed but if that failed we need to write these off. A Resolution, thus, was passed unanimously that, "The investments lying locked in the UTI may be written off'.

Dr. Ahuja informed that the bank accounts of the Trust were still located at Chennai and Mumbai, and he had to operate them through Dr Sridhar and the Treasurer, respectively. Even though a Resolution had been passed last year that the Chennai accounts be shifted to Delhi he had not done so as the procedure was quite time consuming with paper work and there was no Canara Bank branch close to Dr. Ahuja's house.

As the Journal of APSI had not drawn any amount in the last three years it was suggested that the GB be recommended to pass a Resolution that there should be no further incremental increase in the Journal corpus from future APSICON savings and from life membership fees. The Association required money for other administrative and legal purposes and locking such large sums in a corpus which was underutilized only restricted the Trust from making other expenses decided by the Executive.

The budget for the current year was presented by the Treasurer and the estimated expense of Rs 8 lakhs for the legal expenses, and expenses for the new website, were discussed as these were not regularly budgeted expenses and had to be provided for from the existing corpus.

As there is no change on Board of trustees the current Board of trustees are now

Dr. Suresh Gupta – Chairman Dr. Rajeev Ahuja – Executive Trustee Dr. V. Bhattacharya - Member of Board of trustees Dr. Mukund Thatte - Member of Board of trustees Dr. Mukund Reddy– Member of Board of trustees

During the Trustees meeting Trustees have put on record their appreciation for the exemplary work done by Dr. Shailesh Ranade, Treasurer of APSI, during the past six years of his tenure.

The general body approved the trustees report unanimously.

#### 7. Editor's report and accounts for 2016-17.

Dr. Mukund Jagannathan informed the GBM about the progress of the IJPS

-The Journal has published three issues since last GBM.

Journal website has received has received 66,000 hits (accesses) in 2017.

Indexing:

The Journal has renews its indexingsuccessfully in DOAJ in Sept 2017.

In addition it is indexed with Emerging Sources Citation Index, Index Copernicus, Indian Science Abstracts, IndMed, PubMed Central, Scimago Journal Ranking, SCOPUS

Impact factor:

Currently available IF from other sources is 0.51

Finances and proposals:

- Editor has received bill from publishers, which is about 3lakhs. The final finances will be cleared.

- Editor has not received so far advt. money from Ethicon for the last 3 issues. Reminders have been sent
- Editor, expressed strong objection for the proposal for reducing additional corpus from 10% to 5% from savings of each year's APSICON, as proposed by the Executive Trustee. Editor expressed that; such a step will adversely affect future publications.
- To reduce the print cost and financial burden, Hon. Editor requested all members consider opting for only online edition and write to him for cancelling their copies of print.

The Editor also mentioned about Journals acceptance rate, rejections based on plagiarism and reviewers shortage in timely decision on articles.

Hon. Editor addressed few concerns of some members about not being able to publish articles. The editor said, editorial team is bound by reviewers' suggestions.

Prof Mukund Jagannathan thanked the Editorial board members, Deputy editors Dinesh Kadam and Brig P.S. Bhandari as the term of editor is being ended and wished the new editor , for the successful tenure and promised his cooperation.

#### 6. Secretary's report.

#### Amendments to bylaws

The secretary informed the general body that the Proposed changes in APSI bylaws of Article II Clause M – about Conducting Conferences was Printed in Dec. 2016, April and August 2017 Newsletters. The new addition of point No. 7 to be added to Article II Clause M was also circulated with these newsletters. He also informed that E mail sent to all members on 25<sup>th</sup> Oct. to give 24 days' notice for change in bylaws as per rules in our constitution.

The secretary informed the general body that the objective of amendments is as follows

Since the President decides his organising secretary and organising committee it should be responsibility of the President to organise, conduct and manage finances for APSICON.

With introduction of GST additional clause regarding the same needs to be added to the bylaws.

Following are the existing and proposed changes.

#### The new addition of point no. 7 in Article II Clause M is as follows

7. The responsibility of payment of GST / any other applicable taxes related to APSICON lies with President for that year. In case of requirement of additional payment for any tax and or penalty imposed post facto, related to APSICON, President APSI, who conducted APSICON will be responsible. He may be allowed to pay the money from surplus from the conference if any. In case, the amount to be paid towards the Tax is more than surplus from the conference, President APSI for that year will have to pay the amount. APSI Treasury will not be responsible for payment of GST / any other applicable tax, for APSICON at any given time. APSI will not be responsible for any Financial, Tax related or Legal issues related to APSICON . It will be sole responsibility of the President APSI.

The secretary requested President Dr. Iyer to appoint two tellers. He request Dr. Jiten Kulkarni, Dr. Atul Parashar, Dr. Raj Mishra and Dr. Vinita Puri to distribute the ballots and collect the ballot papers. At this juncture Dr. Ahuja proposed that there is no need to take secret ballot on this issue as General body unanimously approves all the amendments to the Bylaws.

Resolved that following amendments are to be adopted to the bylaws of Association of Plastic Surgeons of India in Article II Clause M- Conducting Conferences

2. The President for the year shall be responsible for the administration and financial conduct of the conference and shall be authorised to open and access regional account of APSI by the resolution of the council.

3. The President for the year shall have power to organise and constitute various committees for the proper conduct of the conference.

4. It shall be the task of President for the year to ensure that the conference is founded on basis of self sufficiency and the APSI will not make good any losses sustained .

5. All the surplus funds of the regional account shall vest in APSI. The council shall however give due weight age to the wishes of President for the year to the utilisation of such surpluses.

7. The responsibility of payment of GST / any other applicable taxes related to APSICON lies with President for that year. In case of requirement of additional payment for any tax and or penalty imposed post facto, related to APSICON, President APSI, who conducted APSICON will be responsible. In case, the amount to be paid towards the Tax is more than surplus from the conference, President APSI for that year will have to pay the amount. APSI Treasury will not be responsible for payment of GST / any other applicable tax, for APSICON at any given time. APSI will not be responsible for any Financial, Tax related or Legal issues related to APSICON. It will be sole responsibility of the President APSI.

The above amendments were unanimously passed by the General Body.

The secretary informed that the December newsletter was published after the conference last year which included detailed report on APSICON 2016. Two E newsletters April 2017 and August 2017 were published this year. The E newsletters were circulated to all the members by email individually. They were also published on the website of our association. The announcement for various awards of the association is published in April newsletter every year. He requested the members to watch out for these announcements so that they can apply within stipulated time frame. He informed that application form for fellowships, Grants , awards is now available on the website along with the undertakings required.

The Secretary informed that the associations new website has instated new mail chimp software which gives detailed reports on deliveries, how many members viewed the newsletter etc. using Google Analytics. He also showed analytics reports generated from the website. The Secretary informed that Scanning of Papers of Secretarial office has started and till date 1332 pages are already done .

He informed that Membership Certificates with Id cards were sent by post to members whose membership was approved by GB 2016.

#### 11. Matters arising out of executive council meetings held on 11.3.2017 and 15.11.17.

The secretary informed that the important decisions taken by the EC during Mid Term meeting were circulated to all members via April Newsletter as follows

#### Important Decisions made by APSI Executive Council in its Midterm Meeting

The Mid-term Executive Committee meeting was held on 11th March 2017 at Munnar. In the past president's meetings held during APSICON 2016 valuable suggestions were given by the Past Presidents - To form Scientific Committee of APSI, New Executive Body should meet before the end of the conference, President Elect should also be invited to this meeting of Past Presidents, Create a Legal Cell in APSI, Create a Publicity Cell of APSI and concentrate on Public Awareness Programme. These were sincerely considered and important decisions were taken by the Executive Council.

## The APSI Executive after due deliberations has taken following decisions -

- There will be National Scientific Committee for each APSICON. They will give suggestions to the local scientific committee. The scientific committee chairman of the APSICON will be the final authority in deciding scientific programme.
- 2. The past presidents meeting will be held before the Annual executive committee meeting. The president elect will be invited for the same. The agenda of the same will be circulated by immediate past president in coordination with the current president. The invitations to the past presidents will be responsibility of the current president.
- The EC has formed a committee headed by Dr. Mukunda Reddy including Dr. Satish Bhat and Dr. Atul Shah as its members to take quotations from legal firms in order to form Legal cell at APSI.
- 4. The EC has formed a committee headed by Dr. Surajit Bhattacharya including, Dr. Raja Sabapathy, Dr. V. K. Tiwari and Dr. Shailesh Ranade as its members to take quotations from PR firms regarding publicity cell of APSI.

As per discussion in the GB 2016 - President Dr. Iyer had agreed to give time to the aspiring vice presidential candidates to express their vision for APSI from the podium from this year itself. The candidates will be given time of 3 minutes to express their thoughts after withdrawal time is over. The withdrawal time will be preponed to 2 pm from current 5 pm. It was also unanimously decided that if candidate is found campaigning near the booth he will be debarred from the elections. This will be implemented from APSICON 2017 onwards.

As per suggestion received from Dr. Lokesh Kumar during the last GB 2016, after discussion on pros and cons it was decided to form a strategic planning committee of APSI consisting of Dr. Iyer, Dr. Raja Sabapathy and Dr. Mukund Thatte to prepare 5 year vision document for APSI. It will be document for future presidents to refer to.

Following resolutions were unanimously passed by the executive council during its Mid Term meeting and are being presented to General Body for approval.

Resolved that if a member applies for fellowship/ awards /grants of APSI and is granted the same by the executive council and/or General body and he fails to submit a report on completion of the fellowship / awards / grant he will be prohibited from applying for fellowship/ awards /grants of APSI for period of next three years.

*Resolved that Dr. Parag Sahasrabudhe will be the Webmaster for period of five year for the new website. The core committee will be decided by Dr. Parag Sahasrabudhe.* 

Resolved that that the candidates aspiring for the post of vice president will get three minutes for expressing their views and vision for APSI from the podium .The session for the same will be scheduled a day prior to day of elections after withdrawal time is over. The time for withdrawal of

the candidature will be till 2 PM instead of 5 pm. The session will be scheduled in the main hall of the conference.

Resolved that if funds for awards/grants/fellowships etc. remain unutilised because of whatever reasons, the Executive council should have full Authority to divert the sum for appropriate purpose.

Resolved that Dr. Dinesh Kadam will finalise the MCh/D.N.B. Plastic Surgery curriculum. He will circulate it to all the head of departments of Plastic surgery in the country. The Hon. Secretary will communicate the same to the MCI.

#### All above resolutions were unanimously passed by the General Body.

The secretary informed the General Body that it had passed a resolution in 2015 as stated below.

Resolved that application of a Member having received any international fellowship / Peet Prize once shall be considered for another international fellowship / Peet Prize, after three years only.

He further narrated those applications for podium presentation to this prestigious prize has dropped year on year because of such restrictions. He said that the Executive has already passed resolution below

EC has unanimously resolved that a member who has won PEET PRIZE AWARD can apply for the same again in the subsequent year. He requested General body's approval for the same.

The secretary informed that as per the directives of GB last year Strategic Planning Committee to form a vision document for APSI was formed during the Mid Term EC meeting which consist of Dr. Subramania Iyer- Chairman, Dr. Mukund Thatte, Dr. Raja Sabapathy and Dr. Rajiv Ahuja.

He then requested Dr. Iyer to present the vision document for APSI to the General Body. Dr. Subramania Iyer presented the vision document and print copies of the same were also distributed to the General Body.

The vision document is as follows.

#### Vision document for APSI

#### **1** Objectives of the document and the strategic planning committee

1.1 Background

The activities of APSI at present are the responsibility of the current President assisted by the Secretary and Treasurer. The role of the Secretary and Treasurer are confined to managing the dayto-day affairs of the association. The President defines the major policy goals. Unfortunately, due to the short span of time available during his or her term of one year the President is unable to contribute enough or plan long-term visionary projects. Hence the APSI is losing out in implementing long-term policies or activities that demands continued attention. This lacuna was brought to the attention by the Past Presidents' forum to the General Body of 2016 held in New Delhi. The GB authorized the current President to form a Strategy Planning Committee and provide a vision document for next 5 years. Once approved by the General Body this vision document is to act as a guiding principle on which the Presidents during the next five years can work in continuity for achieving the goals set in the vision document. Accordingly, the President co-opted Dr Raja Sabapathy, Dr Mukund Thatte, Dr Rajeev Ahuja to from the committee and the Hon Secretary Dr. Parag Sahasrabudhe and Treasurer Dr Shailesh Ranade to help in the preparation of the vision document. Inputs were taken from several other persons in relation to the training programme, curriculum, journal etc. The document has been prepared after deliberations among these people and subsequent revisions.

The committee will be in place for 5 years. The current President/ Secretary and treasurer of that year will be member of the committee during that year. The committee will have virtual or physical meetings twice a year. The Secretary will apprise the committee on progress of implementations and committee will give its observations to the secretary who will keep GB informed every year and provide further suggestion.

### **1.2 Objectives**

- a) To define the long term visions of APSI
- b) To identify areas of action to be addressed by the office bearers for next five years and to formulate time bound action plan for each year.
- c) To identify special issues that need attention and further deliberations

# 1.2 a) Defining long term visions of APSI

- i. APSI endeavours to provide opportunities to its members for self-development and help achieve their full potential.
- ii. APSI will strive to preserve the privileges of its members and enhance the standing of the Plastic surgery profession in the community

- APSI will endeavour to create means of access to affordable quality care to all who need
   Plastic, Reconstructive and Aesthetic Surgical services in the country.
- iv. APSI will engage government, regulatory agencies, other sister organizations and medical education policy makers to achieve the above ideals.
- v. APSI endeavours to improve the public perception of Plastic surgery in the country and promote ethical and quality plastic surgery practice with the cooperation of the public.

# 1.2 b) Areas of activities in which attention is to be given in next five years

# i) <u>Streamlining the administration of the APSI activities</u>

a. APSI needs a permanent office. Currently the address is related to either a present or past office bearer, which leads to difficulties in the long run. The current scenario where legal and tax issues will hog any organization, having a permanent office will go a long way. Mumbai will be ideal as the APSI trust registration in the Charity commissioner's office in Mumbai, and the GST registration Priority status

# Urgent within 1 year

Committee comprising of Dr Prabha Yadav, Dr. Vinita Puri, Mukund Thatte and Shailesh Ranade (member secretary) will look into it and give proposal by mid term executive.

b. APSI needs a fulltime / Part time manager to look after day-to-day activities. The manager will work under the secretary to do all communications, web content management, maintenance of documents and helping the lawyers for running the court cases.

The manager will be present during each APSICON at allocated APSI lounge allowing to sort out many issues of members during conference days. The manager will also can attend important meetings and take notes so that we can have documentation and minutes of all the meetings held during the conference or the midterm executive committee meetings.

This is a priority as we have more than 1650 members now. Every year approximately we add 50-60 members, so will reach 2000 mark soon. Priority status

# ii) Improving the public face of Plastic surgery and APSI

By increasing the public awareness about the wide spectrum of work we carry out, the client base of Plastic surgeons can be tremendously increased. This can be achieved by employing an advertising team. The ads created should be catering to the interests of every plastic surgeon in the country. These ads should create awareness about the need of trained Plastic surgeon expertise in varied clinical problems. Publicist can use social media such as Facebook and promoting posts for better visibility. News about significant plastic surgery should be featured from across the country. Invited articles to magazines and papers can also be used as an effective means. The same team will form the strategy for awareness programme every year on the eve of the National Plastic and Reconstructive Surgery day i.e. July 15<sup>th</sup> of every year. Each year the emphasis could be on two or three aspects of Plastic surgery.

The curriculum prepared by APSI is excellent and has to be adopted by all Universities. We can request all the HODs across the country to request their respective universities to push for implementing this curriculum. Association will officially communicate to MCI. Even if it is not legally binding all teaching units offering either DNB or M.Ch. should be encouraged to adopt training with this as the basis.

Priority rating - Immediate

Action plan - Secretary and curriculum committee secretary and chair to persue

# II) Rotation of trainees to other units during training

Each department has its strengths and weaknesses in the spectrum of activity the trainee are exposed. Rotation to other units has not been widely practiced due to the lack of support for this concept from the medical council. The trainee should be offered structured rotation between consortiums of units. For this the universities and medical council should be lobbied to make changes in the present laws governing such training.

Priority rating - Intermediate (2-5 yrs)

Funding required – nil

Action plan

The training Supervisory committee (TSC) will have designated member to lead it and make a report by 1 year

#### III) Nationwide digital teaching network

All the Plastic Surgery units in teaching institutions can connect by Skype or similar virtual meeting facilities. The participating institutions will be doing their routine teaching programmes like case planning sessions, topic discussion and journal clubs televised. This can be viewed by any other center and trainees. The events will be notified by SMS to the members of this programme . The role of APSI (through one designated member of the training supervisory committee) will be to coordinate and

make a time sheet for three months to be published in the APSI website. The new website is enabled to send email reminders to the members .

Priority rating - intermediate (1-2 yrs) Funding needed to be decided after initial evaluations Action plan

TSC with the designated member to report if possible by midterm EC

# IV Restructuring APSI CMEs

The training supervisory subcommittee will design 10 courses. The committee will make the curriculum for these courses and identify faculty members. The committee's term will be of three years. The course will be run by a local leading Plastic surgeon. Funding of these courses need to be relooked. It is supported by Ethicon donation and APSICON 2005 donation. Hence it is to be named as APSI accreditation course ( supported by Ethicon and APSICON 2005 fund).

Priority-Urgent 1yr

Action plan

Formation of the Training Supervisory committee to implement these suggestions.

#### V Surgical skill enhancement programmes

For this we need to have 2to 4 cadaver dissection courses every year. These should be made mandatory for the trainees during their three year course. The cadaver courses can be arranged with participation of anatomy departments. APSI should work with Ethicon or other institutions for APSI endorsed micro vascular courses.

The AO course for maxillofacial trauma should be approached to be endorsed by APSI and made mandatory for the trainees once during the training period.

Priority Intermediate 1-2 yrs

Action plan

The TSC member to report with suggestions

Formation of a **training supervisory committee** with the following members is suggested Dr Rajeev Ahuja- chairman

Commodore G Viswanath , Dr. S Raja Sabapathy, Dr. MR Thatte, Dr. Ramesh Sharma, Dr. A. K. Singh, Dr. Rakesh Khazanchi, Dr. Karoon Agrawal, Dr. Gautam Biswas, Dr. Subramanya

Iyer, Dr Ravi Chittoria (digital network for plastic surgery education) and Dr Amresh Baliarsing (Nation wide cadaver courses).

# IV) International training schemes

- i. International short term fellowships are beneficial to younger plastic surgeons in gaining expertise. There should be increase in number of these posts lasting 1-2 months. Each should carry a bursary of 2000 USD. Liaison work with overseas consultants as well as units should be initiated by the APSI to facilitate the placement of these trainees.
- ii. The scheme to encourage the international trainees to come to India started by the savings of APSICON 2012 fund is a laudable thing, which improves the profile of the Plastic surgery community of India in the international scene. The number can be increased Corpus needs to be augmented.

Priority- Intermediate to long term

Financial requirements- Corpus of 50 to 60 lakhs

The IPRAS and Sariaya award corpus can be merged to give partly fund it

Future APSICONS can be requested

# Action plan

The Restructuring of Awards subcommittee will report after discussing with executive trustee and the treasurer by next APSICON executive committee.

# V) Starting new APSI accredited training fellowships in novel areas of clinical practice

This is aimed at training the younger surgeons and empowering them to take up newer vistas in plastic surgery. They should be 6months to 1 year paid posts in units, which can partner with the APSI for this purpose. Eg. Cerebral Palsy, lymph edema surgery, onco plastic breast surgery. The OMFS society has such a society sponsored fellowship the admission to which is by an exam conducted during the national conference. This will need a fellowship salary of 30-40000 per month for six months to be paid by the APSI as well as identifying two to three units who could absorb them and/or finance them.

Intermediate to long term Financial requirement Rs 50 lakhs corpus to be generated

Action plan

The awards and grants restructuring committee will report to the EC by 2018 APSICON

#### VI) Restructuring of the current fellowships

There are numerous fellowships available, but mostly underutilized. The main reason is for the low amount attached to these fellowships, as the corpus is small. These should be amalgamated or restructured.

Action plan

Awards and grants restructuring committee will report to the SPC and next midterm EC. The committee comprising of V Bhattacharya, Shailesh Ranade, Parag Sahasrabudhe,( member secretary) Rakesh Khazhanji and Subramania Iyer was suggested to the GB.

# iii) Indian Journal of Plastic surgery

There is a need for making our journal more internationally accepted both for readership and article submissions. IJPS currently is PubMed indexed, open access journal both online and print. The journal website receives approximately 20,000 hits every month. There is no impact factor awarded to the journal, The IJPS is financed essentially by the APSI journal corpus. Advertisement are managed by the editor to raise the funding

#### 1. Should we change names to shed the regional image?

Till date 711 journals have changed their names The notable plastic surgery journals include BJPS to JPRAS, Scandinavian to 'Journal of Plastic Surgery and Hand Surgery,' Canadian journal to 'Plastic surgery' Korean journal to 'Archives of plastic surgery'

The downside is only the impact factor. When the new journal starts the impact factor counting stats only in its third year. But this is not a real issue, as we do not have an impact factor.

# 2. Should we have new publisher?

New publisher with more offers could be considered. Publisher needs to provide better editorial assistance and some attractive features such as ahead of print online publication of the article, this will remove delay in publication and provides author early accessibility of the articles.

### 3. Should we remain open access and should there be print version?

To remain open access is necessary at this stage to get more visibility, citation and getting impact factor. However it will come at a cost as the income is only from advertisements. Publishers are interested in promoting the journal only if it is a paid access. Print version is needed at present. But the videos and extra photos can be given as online supplements.

The committee comprising of the former editors of the journal Dr. Surajit, Dr Thatte and Dr Jagannathan with the present editor Dr Dinesh Kadam to look into it and give suggestions by midterm EC.

# iv) Improving relationship with sister specialties and organizations

Plastic surgeons have relationships with other specialists like maxillofacial surgeons, dermatologists, ophthalmologists, ENT surgeons and orthopedic surgeons. These may be either conflicting or complimentary. In general the output of working together is better. On personal grounds the relationship is excellent. Unfortunately this becomes sour when Associations are concerned and often-bitter feelings arise (eg the issue with MFS). This is not healthy. Hence steps to improve the relationship should be made.

- a) Have sessions by these respective associations by turn in the others national conference
- b) Institute respective association accredited training programmes in areas of conflict

Eg offer oral cancer surgical treatment fellowship to MFS by us reciprocated by maxillofacial trauma fellowship by MFS association to us. Surgical dermatology by us to dermatologists and cosmetic dermatology by them to us.

# v) International collaborations

The international visibility of our association is to be improved. There should be more liaisons between the national organizations of other countries as well as consortiums like ICOPLAST, WSRM etc. (strength comes from attendance and contribution in terms of participation and taking active membership roles. But lobbying should be done to make the membership payment to these societies affordable to ours. If needed we should add the agreed amount to the annual membership fee we are proposing) The activities that could be initiated include.

a) Organize APSI session by a team of faculty members in their national meeting. This team will travel and participate on their own, but may be partly supported by APSI in future when funds are available. This will allow us to show case our capabilities and achievements. (they say that we first need to put in registrations and free papers)

- b) Invite a team from another country's association each time for each of our national meeting. Offer them local hospitality and <u>free registration The team can be three to four members. The APSI should subsidize the organizing committee for this gesture. It could be accommodated for 1-2 hrs in the CME section The can run a small plenary session or be included in the keynote/ oration slots</u>
- C) Arrange mutual exchange programmes
   The ASPS APSI summit is in the similar lines.

This is to be planned and executed by a subcommittee called **Liaison subcommittee** of APSI The committee will talk to other associations, identify the partnering institutions and formulate the curriculum. In future the committee can have representative from all the concerned associations.

# 1.2 c) Special issues that need attention and discussion

# 1. Utilization of money generated in APSICON

APSICON is the main revenue generator for APSI. The current practice is that the organizing committee suggests how it should be utilized.

This takes away the freedom from APSI to utilize this amount in a more organized and a visionary way. Some of the funds from previous APSICON are still remaining unutilized. Hence all the funds should be at the disposal of APSI .The APSI will prepare a wish list out of which the organsing committee can choose which is more suitable for them. Each of these contributions will be noted with the tag of that APSICON.

# 2. Request for further named orations/sessions and prizes in APSICON

The Plenary sessions are clogged now. Any further named sessions on the podium will greatly reduce the ability to formulate good scientific programme

It takes away the time for accommodating good work and papers from India.

Hence no further addition of named events that need podium time should be allowed. The request for named events is genuine and more and more requests may come in future.

Possible methods to satisfy these requests may be

- a- To combine a new name to a previously named event. Our lawyers opinion may be sought for clarity
- b- To replace some of the named events which don't have sentimental issues related to it.(Which may be difficult, as everything will have some sentiment attached)
- c- To use the method of prominent standees and projected materials of the person to be honoured to be displayed all across APSICON avenues.
- d- To name halls after people
- e- To Name free paper sessions after people.

This could be an ideal solution when a particular session is named after the specialty of the person in whom it is instituted. (With a definite agreement that it shouldn't be a plenary session)

# 3. <u>Requirements for new named events</u>

Any contribution should have a provision for inflation after ten years. If the people are not capable of doing so, it should be scrapped. The agreement between the sponsoring body and APSI must be explicit in this regard.

Resolved that the Strategic Planning Committee comprising of Dr. Subramania Iyer ( Chairman ) Dr Raja Sabapathy, Dr Mukund Thatte and Dr Rajeev Ahuja will be in place for 5 years. The current President/ Secretary and treasurer of that year will be members of the committee during that year. The committee will have virtual or physical meetings twice a year. The Secretary will apprise the committee on progress of implementations and the committee will give its observations to the secretary who will keep the GB informed every year and provide further suggestions.

Proposed by Dr. Surajit Bhattacharya Seconded by Dr. A.K. Singh

# The General body unanimously passed the above resolution.

Secretary Dr. Parag informed the General Body that he has received an email from Dr. Prabha Yadav regarding utilization of Corpus of APSICON 2015. The salient features are as below.

'APSI has been in existence for 60 years and doing an excellent work with its enthusiastic members. It has been a long standing need to have our own office premises. The Charity Commissioner has been questioning for our own permanent office premises. We really appreciate to have our own office in Mumbai. I will be happy to give 70 lacs for this good cause'.

He further said that The EC has unanimously agreed to explore possibility of having permanent office for APSI in Mumbai. He requested General Body approval for the same. Dr. Iyer said that it is high time that we have our own office in Mumbai as we are registered as Trust in Mumbai. Resolved that the APSI office committee as approved by the Executive Council will consist of Dr. Prabha Yadav, Dr. Mukund Thatte, Dr. Vinita Puri and Dr. Shailesh Ranade( as Member Secretary of the committee). They will submit their report by Mid Term EC 2018.

Proposed by: Dr. Subramania Iyer Seconded by : Dr. Jiten Kulkarni The General Body approved unanimously to have permanent office space in Mumbai.

Resolved that the Executive council is empowered to take appropriate decision regarding a permanent office for APSI in Mumbai if the proposal from the APSI office committee is acceptable and request the Board of Trustees to make necessary funds available for permanent APSI office.

Proposed by Dr. Subramania Iyer Seconded by Dr. Jiten Kulkarni

Resolved that as per the recommendations of APSI office committee, the Executive council is authorised to appoint a fulltime / Part time manager to look after day-to-day activities of APSI. The manager will work under the secretary to do all communications, web content management, maintenance of documents and helping the lawyers for running the court cases. The manager will be present during each APSICON at the allocated APSI lounge allowing sorting out any issues of members during conference days. The manager will also attend important meetings and take notes so that we can have documentation and minutes of all the meetings held during the conference or the mid term executive committee meetings.

Resolved that to Improve the public face of Plastic surgery and APSI an advertising team to be employed by committee headed by Dr. Raja Sabapathy . The members of this committee will be decided by Dr. Raja Sabapathy.

Resolved that Training Supervisory committee (TSC) Led by Dr Rajeev Ahuja, consisting of Commodore Viswanath (General Principles and Flaps), S Raja Sabapathy (Hand and Extremities ), MR Thatte (Brachial Plexus, Nerve injuries and Tendon transfers), Dr Ramesh Sharma(Craniofacial Surgery and Maxillo facial Trauma), Dr AK Singh (Clefts and associated anomalies), Dr Rakesh Khazanchi (Aesthetic Surgery), Dr Karoon Agrawal (Breast, Trunk and Genitalia), Dr Rajeev Ahuja(Burns), Dr Gautam Biswas (Head and Neck (Oncology, reconstruction), Dr Subramania Iyer (Miscellaneous: Facial reconstruction, Ear), Dr Ravi Chittoria report on implementation of digital network, Dr Amresh Baliarsing(Nation wide cadaver courses) Will restructure APSI CME's. The committee tenure will be for 3 years.

Resolved that Liaison committee consisting of Dr V Bhattacharya, Dr. Subramania Iyer, Dr Lokesh Kumar, Dr. Karoon Agarwal, Dr. Ramchandran and Dr.Gautam Biswas will do liaison between the national organizations of other specialties in our country and plastic surgery associations and consortiums like ICOPLAST, WSRM etc.

Resolved that APSI will submit a wish list depending on the priorities regarding utilization of savings of future APSICONS. The Organizing Chairman and the Organizing Committee will have the freedom to choose from the wish list regarding allocation of savings of their APSICONS.

All above resolutions were unanimously approved by the General Body.

("APSICON-2013 Account") with effect from the date of the resolution.

RESOLVED FURTHER THAT the New Authorized Signatories, be and are hereby authorized, to jointly sign all documents, forms and do all such acts, deeds and things as may be considered necessary, expedient, incidental or desirable to close the APSICON-2013 Account.

He then requested General Body's approval for the same.

#### The above resolutions were passed unanimously by the General Body.

Dr. Sahasrabudhe informed the members that necessary papers were submitted to HDFC Bank however the bank had replied that they had not received any papers in the said matter. He further informed that he had visited on the HDFC branch in Pune and had received the account closure letter from the bank and a Demand Draft of the amount lying in the said account. The secretary said that it was later on handed over to the Hon. Treasurer. The issue of APSICON 2013 bank account is closed herewith.

The President specially thanked secretary Dr. Parag Sahasrabudhe for his work since the matter was going on and on and the bank was not ready to provide any assistance. The members appreciated the efforts taken by the secretary.

## **Civil Suit against APSI**

The secretary informed that immediately after conclusion of the last APSICON the office of APSI received 249 page documents which was copy of the civil suit filed by Dr. Ashok Gupta against Association of plastic surgeons of India. In the same suit the plaintiff has sought reliefs for setting aside his termination and also challenged APSI's bye-laws.

APSI has not officially received anything from the court as of date and this copy of the civil suit was received from the plaintiff's advocates. The secretary showed 249 page documents to the GB and said that it is available for them to see after the meeting.

The secretary said that approval for appointment of the lawyers on behalf of APSI – M/S Wadia Gandhy and Co. "was electronically taken from the trustees and the executive Council.

He informed that as per the lawyer's advice this news was published in the associations December 2016 newsletter which is as follows

# Matter printed in Dec. Newsletter

"Vide letter dated November 29, 2016, the APSI office has received a copy of the Suit filed by Dr. Ashok Gupta against APSI before the Bombay City Civil Court, Bombay, being Civil Suit (Lodg.) No.13334 of 2016. In the said Suit, Dr. Gupta has sought reliefs for setting aside his termination and also challenged APSI's bye-laws. In this regard, the President and the Executive Council have decided to appoint the same firm of Lawyers which had assisted APSI in the said issue previously, i.e. M/s. Wadia Ghandy & Co. Please be informed that the necessary action is being taken in this matter."

The plaintiff states and submits that the concerned members of the Executive Council of the defendant, which consists among others Dr. Rajiv B Ahuja, Executive Trustee, Board of Trustee APSI, Dr. V Bhattacharya Member Board of Trustee APSI, Dr. Prabha Yadav, being the President APSI for 2015 and member of Executive Committee, Dr. Ramesh Sharma, being the President APSI for 2014 and member of Executive Committee and Dr. Milind Wagh, Member Executive Council of APSI, against whom the plaintiff has made complaint, started nursing serious grudge against the plaintiff and therefore, in order to take revenge from the plaintiff and cover up their misdeeds, invented an ingenious method to ensure that the plaintiff is unable to proceed further in the matter and consequently, they further conspired with each other by hatching further criminal conspiracy and in furtherance, abruptly suspended the membership of the plaintiff with defendant vide their letter dated 27.12.2015, and thereby refrained and prohibited him from attending the 50th Annual General Body meeting of the defendant, to be held on 30.12.2015. It is pertinent to mention that the plaintiff is a life member of good standing. It is significant to note that in the said suspension notice dated 27.12.2015, no specific grounds / reasons were assigned and therefore, it can be clearly seen that the plaintiff was suspended with ulterior motive to deprive him off in participating the 50<sup>th</sup> Annual General Body Meeting to be held on 30.12.2015. Hereto annexed and marked as Exhibit-'A' is the copy of the said suspension letter / notice dated 27.12.2015.

The Hon. Secretary said that following are the prayer made by Plaintiff to the honourable court.

On 22<sup>nd</sup> Feb. 2017 Our Lawyers appeared in the court for hearing and sought time to file written statement. On 10<sup>th</sup> march i.e. yesterday Written Statement was submitted by our Lawyers on behalf of APSI to the court. On 11<sup>th</sup> July 2017 application for rejection of the Plaint under order7 rule 11 was made by our Lawyers. The Secretary informed that till date total 7 hearings have taken place and next is on 20th Dec. 2017.

Hon. Secretary showed the resolutions suggested by the lawyers which were passed unanimously by the Mid Term EC regarding the civil suit which are as below.

RESOLVED THAT, consent of APSI, be and is hereby accorded, to the concerned members elected and holding the post of President and the Vice President ('Authorized Representatives'), to institute, commence and defend legal proceedings, by or against APSI, in connection with the disputes raised by Dr. Ashok Gupta, including Suit No.102951 of 2016 filed by him before the Hon'ble Bombay City Civil Court against APSI. RESOLVED FURTHER THAT the Authorized Representatives, be and are hereby authorized, to consult and appoint WadiaGhandy& Co. as APSI's advocates; Once appointed, to give to the said advocates, advances towards their fees and expenses which they shall be incurring for and on behalf of APSI and to pay their fees on the advocates raising their bills/ memos.

RESOLVED FURTHER THAT the Authorized Representatives, be and are hereby authorized, to sign vakalatanama and all such pleadings, including written statements, replies, affidavits, petitions and such further and other proceedings as advised by the above advocates and do all such acts, deeds, matters and things which are incidental and ancillary thereto, for and on behalf of APSI, including signing all communications in this regard.

RESOLVED FURTHER THAT the Authorized Representatives, be and are hereby authorized, only after the Executive Council has passed a resolution by 2/3<sup>rd</sup> majority in that regard, to settle, withDr.aw, compromise the above proceedings and for such purpose, sign consent terms, minutes of the orders and such further writings, as approved by the Executive Council and as advised by the above advocates.

RESOLVED FURTHER THAT, the Authorized Representatives, be and are hereby authorized to act severally and further delegate the aforesaid powers to such officials of APSI as may be necessary from time to time.

**RESOLVED FURTHER THAT, the certified true copy of the resolution be forwarded to such persons as may be necessary.** 



# **APSI Accredited -PG CME courses**

He informed that he had received an email from Dr. Raj Mishra asking questions on APSICON 2005 Ethicon APSI Accreditation course. The questions were as follows:

Whether the word APSICON 2015 be used at every place? Whether the word Ethicon should be retained or omitted? Whether the first 40 registration should be refunded and what is the name of the course and how much support that would be provided from APSI side.

On the above questions Dr. Parag Sahasrabudhe had replied to him that the said questions would be discussed in the executive committee meeting.

Similar mail was received from Dr. Raja Sabapathy asking for rules and regulations for APSI ETHICON Accredited courses.

Dr. Parag Sahasrabudhe had written an E mail to Dr. Ahuja for discussing on the above matters. The highlights of changes from APSICON 2005 Ethicon APSI Accreditation course changes till date are as follows:

• GB 2009 – Prefix 'APSICON 2005' added as per email from Dr. Ahuja Not mentioned in the GB minutes 2009

- Since tenure of last Secretary we are signing agreement for each course
- We take agreement from organisers of each course
- Clause of refunding first 40 postgraduate student is not in ETHICON agreement so not mandatory
- Rs. 5 lakhs comes from ETHICON every year for 3 courses. Approx. Sum of Rs. 15000-20000 comes from savings of APSICON 2005 for two courses every year.
- Course is for one and half day.

The above highlights were noted unanimously. Dr. Iyer said that as major support comes from ETHICON, their name cannot be deleted. Dr. Iyer suggested that it should be called as **APSI Accreditation course supported by ETHICON and APSICON 2005.** The secretary informed that the EC has unanimously agreed to the same.

Resolved that the postgraduate courses conducted every year will be called as 'APSI accreditation course (supported by Ethicon and APSICON 2005 fund).' The Hon Secretary shall sign agreement for each course with Ethicon on behalf of APSI. The convener of each course shall sign agreement with APSI.
