Thind and having worked as Pool Officer with Prof. Mander, Dr Ravi got an opportunity to train under Prof. A. G. Thomas at CMC, Ludhiana for microvascular surgery

**Journey as a Teacher:** After completing Post M.Ch. microvascular training in CMC Ludhiana, he joined the faculty at PGIMS, Rohtak and headed the department there. After working in teaching institutes as faculty for 11 years, in 2002 decided to shift to my hometown Amritsar and established the Department of Plastic Surgery at Amandeep Hospital. Today, after 18 years, it is one of the biggest departments of Plastic Surgery in private sector with six full time qualified Plastic Surgeons, we have a DNB training programme since 2010 and perform more than 3000 surgeries per year covering various subspecialties of Plastic Surgery.

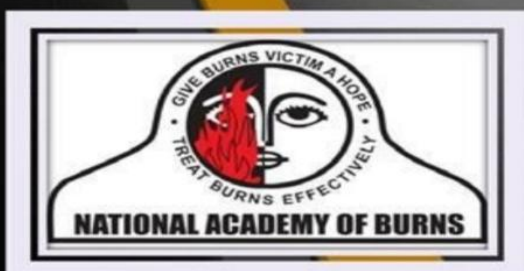

#### **1. Opening remarks by the president.**

#### **2. Reading the notice of the meeting.**

#### **3. Condolences to deceased members**

The secretary informed that Dr. Dias passed away on 28<sup>th</sup> Jan 2018. He was appointed as Hon. Prof. of Plastic Surgery at Sion hospital on 01.01.1978 and he established the Department of Plastic Surgery at Sion Hospital in 1979 and headed the dept till 1984. His Original Publications are Immediate urethroplasty for acute retention following Chronic stricture of the urethra, Bipedicle flaps in the correction of burns contracture, obviating the need for a splint, The SEPA flap, which increased and revolutionized the options for coverage of hand defects and The posterior auricular (PARAS) flap for facial defects, ensuring a hidden donor site.

The secretary informed that Dr. Bijoy Methil Passed away on 29<sup>th</sup> Jan. 2018 in Bike Accident. He passed MCH plastic Surgery from Baroda 2004 and did his Fellowship Microsurgery Chang Gung Hospital Taiwan and Fellowship Aesthetic Surgery St. Vincent's Hospital Sydney Australia. He was avid biker and travelled across India and in an unfortunate accident he passed away on 29<sup>th</sup> Jan 2018.

The secretary informed that Dr. Ashraf Darji founder Prof. and Head Dept. Plastic Surgery- Shere e Kashmir Institute of Med. Sciences Srinagar passed away on 22/11 2018. He was Alumni of PGI Chandigarh institute and retired as Dean of the Institute in 2013.

The secretary informed the members that Dr. ACH Watson passed away this year. His contribution to field of cleft surgery is known to all and he was instrumental in training many plastic surgeons in our country. He was Editor of then BJPS and President of British Association of Plastic Surgeons (BAPS).He was an honorary member of our association since 2010. He has greatly helped the Indian Journal of Plastic Surgery and has given similar editorial inputs to „The Short Notes in Plastic Surgery“.

#### **Audited Accounts of APSI**

Audited Accounts of APSI were circulated to all members by email for their approval before submission to Income Tax Department and Charity Commissioner's Office. I do hope that you have received them and gone through them. I seek the approval of General Body for the same.

***The audited accounts were approved by all the members of GB unanimously.***

This year the SSNM & Associates, Chartered Accountants, Mumbai did the amalgamation of all audited accounts. I thank CA Mahesh Malushte & CA Rajeev Gupta for their efforts and help. I sincerely thank Dr Rajeev Ahuja, Dr. Subramania Iyer, Dr. Karoon Agrawal, Dr. Surajit Bhattacharya, Brig. S. Mehrotra & Dr. Mukund Jagannathan for submitting their respective accounts within stipulated

time. This allowed the Hon. Treasurer to circulate the Amalgamated Audited Accounts to all the members of APSI by email, well in advance before submission.

#### **Filing of Returns to Income Tax Department & Charity Commissioner's Office**

##### **Decisions at the General Body Meeting held at Kochi**

“APSI Executive had an extensive discussion on GST, related to Membership Fees. Advice given by APSI GST Consultant as well as other consultants was considered. In view of lack of clarity about GST, it has been unanimously decided by EC that we will hold on with GST Payment towards membership fees, for new members of APSI for now. APSI EC will take appropriate decision, as soon as regulations are clear. I request GB to permit EC to take an appropriate decision at the right moment”.

*The members of the General Body unanimously approved the above resolution.*

##### **Decisions at the Midterm Executive Council Meeting held at Lucknow in February 2018**

“APSI Executive had an extensive discussion on GST, during midterm EC Meeting in Lucknow towards Life Membership Fees. It was unanimously decided by EC, that APSI would make GST Payment towards membership fees from APSI Account, for members who had paid membership fees without additional GST, in the current financial year after application of GST. For new members APSI shall collect additional GST on Membership Fees and the new Fee structure should be displayed on APSI website with immediate effect”.

Accordingly, APSI Treasurer has paid GST from APSI Account for members registered previously with old registration fees in last financial year. Now GST on membership Fees is collected from members and is now being regularly paid to GST department.

From now on Our Hon. Treasurer Dr Sameek Bhattacharya will take charge of payment of GST. Relevant necessary information, including passwords will be forwarded to new Treasurer soon.

For records purpose each APSICON / Editor will have to submit full details of sponsorship amount collected, with payment of TDS / GST done / not done & if done , the exact amount. This will help to resolve all future disputes about GST related to APSI.

#### **Audited Accounts of Midterm APSI Ethicon PG CME held at Kolkata**

Audited Accounts of APSI Ethicon PG CME, Kolkata were submitted by Convener, Dr.Gautam Biswas. Surplus worth Rs. 92,818 was transferred to APSI.

#### **Grants from Ethicon**

Ethicon supports three PG CME Meetings with a Grant worth Rs. 5,00,000 each year. I sincerely thank Ethicon Division of Johnson & Johnson for their constant support.

Treasurer's Office has not received a Grant worth Rs. 3, 00,000 from Ethicon for professorships & Travelling Fellowships for the years 2016 & 2017. Ethicon has promised that amount worth Rs 3, 00,000 will be paid to APSI towards Awards already declared, though new Fellowships and Professorships will not be granted.

Treasurer has received Funds from Ethicon for PG CME Course held during APSICON 2018 & the funds have already been transferred to APSICON 2018 Account. Treasurer has not received any Funds from Ethicon for the next midterm Ethicon APSI Accredited PG CME Course until now.

#### **APSICON 2012 Overseas Travelling Fellowship**

The APSICON 2012 Overseas Travelling Fellowship Award money could not be transferred to Dr Kibria from Bangladesh, as he does not have an Indian Account. In spite of submission of multiple documents as per directives of the Bank authorities, the bank has failed to transfer the funds to the awardee's account.

Treasurer's Office has never paid any awardee, his or her award in cash payment. This matter was

9. The Treasurer placed the need for a payment gateway in the website and informed that Oriental Bank of Commerce is ready to provide the services. The proposal for payment gateway in APSI website was unanimously accepted and authorized the Treasurer to go ahead with the procedure and make necessary payment.

Treasurer's Report was passed unanimously by all the members present in the General Body meeting.

The secretary informed that there has been smooth transition of Treasurers account and congratulated Dr. Sameek Bhattacharya and Dr. Shailesh Ranade for same. Dr. Surajit Bhattacharya said that Dr.

Ranade has been the best treasurer of this association and e would like to see him in higher positions of the office in near future. The General body applauded the efforts take by Dr. Ranade to streamline the Treasurers' office.

#### **10. Trustee's report for the year 2017-18.**

Dr. R B Ahuja presented the accounts for the year ending 31<sup>st</sup> March 2018. The highlights of which were:

The Corpus of the trust was Rs. 6.223 Crores of which 6.217 Crores was in Bank Deposits and Rs 0.4168Crores in the Savings Bank Account of the Trust.

The additions during the FY 2017-18were :

1,656.82 No savings were received from APSICON 2017 till

31<sup>st</sup> October 2018.

The utilization report of the Treasurer was discussed and found to be in order.

Dr. R B Ahuja informed that in the current year again all existing corpus over one year were augmented by 15% of the interest accrued, to be in line with tax regulations. All unawarded amount was considered as income and not merged with the Trust corpus.

All details of the balance sheet, corpus positions and investments were displayed by way of Power Point Presentation by Dr.R B Ahuja and they were duly approved. The entire amount with the Trust was invested and earmarked in designated corpus and there was hardly any unallocated amount now.

Ear marked corpus was Rs. 6.223

Crores Total current corpus was Rs.

6.584 Crores.

He informed that the final amalgamated accounts of APSI had been duly submitted to income tax authorities and the charity commissioner, before 30<sup>th</sup> September 2018, by Dr. Shailesh Ranade.

Dr.R B Ahuja informed that till so far, an adhoc amount of Rs 25.00 lakhs had been provided to the incoming Treasurer, Dr. Sameek Bhattacharya, for the year 2018-2019. All awards in the year 2018- 2019 shall be made by calculating interest at 7% even if the interest rates had fallen quite low.



Last year the Trust had paid awards at 6% interest. A higher rate was paid this year because the Trust needs to spend 85% of the interest generated during the year. In the current year the Trust expects an income of Rs 50 Lakh (calculated @ average 6.25% rate of return) and so it has been advised by CA that at least 42.5 lakhs need to be spent on activities. It was discussed that we need to spend 85% of the interest accrued each year or there shall be a tax liability.

Dr.R B Ahuja also informed that even though he had taken the General Body approval to write off the small amount invested in UTI (for last 2 decades) because it involved a long drawn procedure to get these linked to our current account and the new registered address; and to have the change of signatories in the investment, he had initiated the process through an investing agent and was very hopeful of getting the securities redeemed by the end of the current year. No money is being paid to the agent for his help in the matter. The efforts were appreciated by all.

### **Matters pertaining to court cases**

Dr.R B Ahuja informed the status of the two cases filed by Dr. Ashok Gupta, one the civil suit and the other with the Charity Commissioner, Mumbai. He informed that Dr.Ashok Gupta had further lodged a complaint with the grievance cell of the Charity Commissioner, Mumbai with the same issues as the case in that office, and for which he along with Dr.Shailesh Ranade, Dr. Parag Sahasrabudhe and Dr.Mukund Thatte attended the summons issued by the inspector of that office. All documents asked of us were shown to the inspector but due to paucity of time he requested another visit to the registered address of the Trust to inspect the remaining documents and accounts. Meanwhile, the advocate representing the Trust in the Charity Commissioner's Office was informed of this development and he lodged a counter complaint on our behalf, stating that both the matters were the same only and legally only one could be entertained and investigated. Thus, the matter with the grievance cell was put on hold by the Charity Commissioner. In his complaint, to the grievance cell, Dr.Ashok Gupta had even alleged that the Joint Charity Commissioner hearing the casewas working at the directions of our advocate. This was viewed very seriously by the Joint Charity Commissioner. In the civil suit, fresh dates of hearing were being given each time as the matter was still quite recent and the court had other pressing cases to deal with.

Dr Ahuja informed that it was decided in the Trust meeting that all the five Trustees should continue for a further period of five years. Dr. R B Ahuja would continue as the Executive Trustee.

### **7. Editor's report and accounts for 2017-18.**

Hon Editor informed that, the IJPS completed 50 years of publication since 1968.

Hon editor appraised the GB about new editorial team, the introduction of business editor and publication of 4 issues following 2017 GBM.

Many complaints on not receiving print copies were resolved by the editor, with updating over 200 members addresses, which was notified through Yahoo group.

***Decision to Change publisher to Thieme*** was informed to the GB, and details of the process, advantages and various bidding proposals as detailed in EC meeting was explained to the GB. The IJPS will be published by Thieme from 2019, onwards.

Editor urged the members to submit research articles of Level & II evidence and experimental research articles to improve the quality. Report was concluded by thanking the members and the chair.

The general body approved the Editors report unanimously.

#### **6. Secretary's report.**

The secretary informed that the December 2017 newsletter was published after the conference last year which included detailed report on APSICON 2017. The April e newsletters were circulated to all the members by email individually. It was also published on the website of our association. The announcement for various awards of the association is published in April newsletter every year. I request the members to watch out for these announcements so that they can apply within stipulated time frame. The August newsletter was published and circulated to all the members. The mail chimp report was shown to the General Body.

Membership Certificates with ID cards were sent by post to members whose Life membership was approved by GB 2017.

**The general body on recommendations of the executive council accepted these reports for appropriate disbursement of the award amount cheque, citations and medals at next annual conference. Secretary thanked the executive council for continuous help during the year. He also thanked the past presidents, Executive Trustee Dr. Rajeev Ahuja and the board of trustees for their constant advice and active supervisory role in functioning of the association.

#### **11. Matters arising out of executive council meetings held on 25.2.2018 and 25.11.18.**

##### **A) Strategic Planning Committee Report**

The secretary requested Dr Subramania Iyer chairman of the strategic planning committee to present the report. Dr Iyer said that this committee was formed last year by the general body with the idea that we should have some continuity in the thought process about future of our association. The idea was to prepare wish list for future APSICONS and for future presidents to fulfil it so that we have a broad vision for our association. APSI office is the first priority and it was discussed in the meeting that till the time we find a space for the office we can appoint staff and start paying for their services so that by the time we get an office space the staff is ready to shift to new premises. Award restructuring committee has done a tremendous job in amalgamating awards and instructing the new awards as well. The training supervisory committee has prepared modules for the post graduate courses so that they will be held in more structured way. Regarding the Publicity committee Dr Raja has a great vision and he wanted funds worth a crore rupees to start with but after discussing he"s agreed that he would start the work with whatever amount of savings he has from his conference to begin with and then maybe the future APSICONS savings can be added for the publicity work. We had a good progress regarding the Liaison work with ASPs . We had meeting with them last year and secretary will update the general body regarding their proposal and we are happy that it is turning in our favour. As regards to the local sister associations like maxillofacial Association, dermatology etc. the committee feels that we should have association with them . The maxillofacial Association has agreed to have a session of plastic surgeons in their next annual meeting of the topics that we suggest. The legal cell is finalising the consents for various procedures but more work needs to be done by the legal cell.

Dr Lokesh said that this committee is the most important committee for our association he suggested that the chairman of the committee should be the President-elect so that



she can continue to work for two years. He also suggested that this committee should be broad-based and should have 10 to 15 people from younger generation so that we can get ideas and those can be implemented in future .Dr Makhija said that if we want to go and have sessions in other speciality conferences they would also request us to do so - are we ready to give time in our scientific program for the other associations ? Dr Surajit Bhattacharya said that this was discussed in the meeting and we are ready for maybe a breakaway station from other speciality in our future conferences. Dr. Ankur Bhatnagar said that we can have a CME lecture during our CME from other specialities. Dr Raja Sabapathy say said that instead of CME day we can have a breakaway station maybe one year we can have dermatology next year we can have orthopaedic surgeon next year we can have maxillofacial surgeon and so on.

## **B) APSI office committee report**

The secretary informed that the committee is working hard to find suitable space of for purchase in Mumbai. They are looking at upcoming building of Indian medical Association in Mumbai so that it will be helpful for us in sharing some infrastructure cost with other specialities. Till the time the space is finalised it was discussed in the executive council that we should appoint staff which will start working for the association so that they will be well trained when the office is established. The secretary proposed following resolution to the general body

## **C ) Award restructuring committee**

Secretary Dr Parag Sahasrabudhe requested Professor V. Bhattacharya chairman of the award restructuring committee to present the final report to this general body. He informed that the interim report was presented in the mid-term executive council. Inputs were taken from the executive council and the final report was published in the August newsletter of our association.

Dr V Bhattacharya started with opening comments as follows

He requested all the members of the General body to listen carefully to his presentation and note down the points and then ask questions at the end of his presentation. He said that he is presenting the report on behalf of the award restructuring committee and these are the recommendations given by the committee regarding the various awards.

Dr. V Bhattacharya said that the award committee as approved by the GB was as follows.

He further said that we have worked with sincerity and lot of thought has gone into the suggestions from the committee. He said that Hon. Secretary has put in lot of efforts to prepare master chart for all the awards and orations /CME – total of 51 awards. The secretary showed the printout to the GB and it was projected on screen as well. The GB applauded the efforts done by the secretary.

Dr. Bhattacharya said that the chart contains all the details about each award- who instated it , with amount at that point in time and interest generated for each award etc. Dr. Bhattacharya said that First meeting was on 10th Feb. 2018 at Aurangabad. Interim document was prepared, which was presented to the Midterm EC held on 25th Feb. 2018 at Luck now. Suggestions were received from the EC regarding the same. Second meeting was held at Medanta, Medicity ,Gurgoan on 2nd June 2018 which was attended by all members and by President APSI.

**PRINCIPLES** we followed were

1. Appropriate award amount to be generated out of the corpus considering present requirements.
2. **No plenary podium time mandatorily to be given to new awards-** President for that year will have his freedom to do so if he/she wishes.
3. **No new award to be perpetual.** Any new award instated should have time limit of 5-10 years. The Award will automatically be stopped after stipulated date. If the award instituting authorities want to continue the award they should send fresh proposal to EC a year in advance of stipulated date. The EC will then deliberate and present it to GB for approval. There should be agreement signed between APSI and award instituting authorities to this effect. In case the award is discontinued award instituting authorities cannot claim back the corpus donation.
4. **No compromise on time for free papers.**
5. Instating of new orations / symposia to be restricted.
6. Try to free some more plenary podium time by restructuring the awards If possible so as to help the local organising committee with more flexibility.
7. The new award initiator or group **should have good standing** in the association as determined by the executive committee before accepting to install new award.

The committee feels that the **following criteria may be adopted in selecting persons to be honoured**

1. Academic contribution
2. Administrative contribution to APSI
3. Consistent active participation in activities of APSI
4. Scientific publications
5. Organisation of workshops, conferences etc.
6. Contribution of individual to APSI and Plastic surgery in whose name the award is proposed has to be unique and should be discussed in depth by the executive committee before submitting to the GB. If any of the initiator or recipient of the award is a member of the executive committee he or she should abstain from participating in the decision making process.
7. No decision is expected to be unanimous however in democracy majority will prevail.
8. Every proposal may not be implemented in Toto.
9. If feasible living legends should have a place in the honours list as this will be more meaningful than a posthumous recognition of the services by any individual.

## **SUGGESTIONS FROM THE COMMITTEE**

### **A. Instating new awards/ Lectures etc.**

#### **1. Acknowledging senior Members of the Association**

surgery Dr. R Venkatswamy – Hand surgery

**The breakaway sessions of above respective subcategories should be named as per above individuals for next 5 years. APSI wishes to recognise their contribution. There is no cost involved and hence will not need any contributions for instituting them.**

- **2. Leadership Award –**

**„APSI Raja Sabapathy Leadership award’ (supported by Dr. S. Guha).**

- The selection to be done by the President, Imm. Past president and President elect along with one members of the EC and Dr. Raja Sabapathy for first 3 years
- No podium time is given for this award.
- The amount to be paid to APSI is Rs. 10 Lacs for duration of 10 Years. The Award will automatically be stopped after stipulated date. If the award instituting authorities want to continue the award they should send fresh proposal to EC a year in advance of stipulated date. The EC will then deliberate and present it to GB for approval.
- There should be agreement signed between APSI and award instituting authorities to this effect.
- In case the award is discontinued award instituting authorities cannot claim back the corpus donation. APSI will have full authority to utilize the corpus.
- The interest generated from this corpus will be paid in full to the awardees for that year. Dr. Bhattacharya said that he requests Dr Sabapathy to note this and comment at end of his presentation.

**3. Naming main hall of the conference**

- The main hall of the conference can be named after an individual Plastic Surgeon with significant contribution to plastic surgery. The amount proposed is Rs. 20 lakhs for 5 year duration. A pharma company or any other company or an individual can donate the corpus for the same. Donors name will be acknowledged as –Dr. X hall (supported by .....). At the end of 5 years it will be open again for sponsorship.
- A standee in recognition of the name will be put up at prominent spaces outside and inside the hall, near podium etc. All printing stationary and website of APSICON will mention it. The local organising committee will take care of all these arrangements. The interest generated from this corpus will be utilised for administrative office expenses of APSI.

**4. Naming side halls of the conference**

- The side halls of the conference can also be named on similar grounds. The amount 10 lakhs for duration of 5 year . The rest of criteria remain same as above.

**5. Starting new visiting professorships and National Travelling fellowships**

- **New visiting professorships** can be started in Microsurgery, Hand surgery, Plastic surgery, cosmetic surgery, cleft and craniofacial surgery etc. Similarly **Visiting National Travelling fellowships** can be started in similar sub specialities. They can be named after an individual. The amount for professorship will be Rs. 1,50,000 and for national Travelling fellowship will be Rs. 1,00,000. The total amount of Rs. 2,50,000 needs to be paid for one professorship and one national travelling fellowship by the person who intends to start these fellowships. So we can have 5 such sponsors each paying Rs. 2,50,000. The entire interest amount will be handed over to awardees. APSI will not earn anything out of this .
- Sponsors name will be acknowledged as (supported by ---). The president APSI will have the authority to choose names of professors for each subspecialty and EC and GB will finalise the same every year.

**6. Starting new international travelling fellowships**

- Additional international travelling fellowships can be started and named after an individual. The minimum corpus should be 20 lakhs. At 6 % it will generate interest of 1.2 lakhs per year. Currently we get more applications for International fellowships

than National ones.

- The duration will be for 10 years. The interest generated will be given to the fellow. The fellowship will be announced every year in April e newsletter of the association. Applications to be sent to Hon. Secretary and EC and GB will do the selection.



### 7. Naming existing Guest lectures

- These existing Guest lecture can be named after an individual. The proposed charges for same will be 10 lakhs for 5 yrs duration and 20 lakhs for 10 year duration. After the tenure is over new names can be added. The same person or group can continue for next 5 years by adding appropriate amount to the corpus as decided by the EC at that point of time. The corpus will remain with APSI and it cannot be claimed back by the initiators. Maximum two such guest lecturers can be planned. Out of the interest generated on this corpus part of it will be paid towards reimbursement of invited faculty for said guest lecturer and part of it will be utilised by APSI for its activities. The percentage will be decided by the EC from time to time. The lectures should not exceed 15 minutes and should not have any frills/felicitations etc attached to it.

### 8. Naming lead lectures in Breakaway sessions

- The breakaway sessions can have a lead lecture in name of an individual. Currently we have I T Jackson cleft and craniofacial award as lead lecture in cleft and craniofacial session . Similarly we can have Lead lectures in Hand surgery, Microsurgery, burns, Brachial plexus etc. in that particular session. The corpus for same will be 5 lakhs for 5 year duration. The certificate can be given at the same time after the lead lecture. The selection will be done by the President APSI. Award instating authorities can suggest names to the President. It should be informed to Secretarial office before Annual EC and GB one year in advance for approval.

### 9. Resident forum and Innovation forum

As per wishes of the local organising committee they can have these two forums during each APSICON

Dr. Bhattacharya said that following are the OPTIONS FOR APSICON 16/17/18 SAVINGS. This is a wish list of APSI .

- Starting new international travelling fellowships
- Naming existing Guest lectures
- Naming lead lectures in Breakaway sessions
- Augmenting corpus of Charles pinto CME, Shushruta oration, PEET Prize and Kilner essay and APSI best paper award

- Augmenting corpus of other existing awards

Dr. Bhattacharya thanked the GB for listening carefully and giving him the opportunity.

After the presentation from Dr V Bhattacharya, Dr Suresh Gupta commented as follows

He congratulated the committee for the excellent job that they have done. He said that the committee has respected the wishes of donors, otherwise it would have been inappropriate on the part of a APSI and would have broken the trust of the donors because we are finally a trust. He asked whether the committee has totalled amount of money that will be required on behalf of the Association.

V. Bhattacharya said that the secretary will be responding to your comments and he requested the secretary to go ahead and request those individuals who are supposed to comment after his presentation one by one so that we can have more fruitful discussion.

- Dr Surajit Bhattacharya said that when we started this process the sentiments of the awards were given priority over the finances so no existing names have been dropped. Secretary Dr Parag Sahasrabudhe said that he will go through the presentation Slides once again and request the individuals to give comments. He requested Dr Raja Sabapathy to comment on APSI Dr Raja Sabapathy leadership award and the APSI education foundation award.

Dr Raja Sabapathy said that he wanted that the publicity work should be done on a larger scale for which the amount of finances required will be very high. If we hire a good professional management firm, it will identify the Lacuna and they will be able to give us solutions to correct them. To achieve this in tune with the other international associations we will have to have a corpus to the tune of one crore rupees which is currently not available with us so what we have thought is that if the general body agrees I will add more names in the committee and we will go ahead with employing a management firm and start taking things forward. I think this will be a path breaking thing for the association and it will benefit the association in the long run. The second thing is about the leadership award which is instituted by Dr Somesh Goa in my name. Originally Dr Guha's idea was to start an Oration in name of Shushruta as it is done in the British Association . The idea is to start an award in the association to nurture young budding surgeons from the association to send them aboard and train them. This will benefit the association in the long run. He wishes that award should be minimum of one lakh rupees and this should be used by the person who is selected to upgrade his knowledge and leadership skills. Person chosen person should be either heading a big unit or he can be an editor who can go and see how the PRS works can have a day with the editor of the other journals so that it will benefit the Association and our journal in the long run. The committee would be to identify the future leaders of the Association and nurture them for our own benefit in the long run.

Dr Surajit Bhattacharya said that the executive extensively deliberated on this issue and the only hitch it has is that the amount of one lakh to be awarded to the awardee

because out of the corpus donation of 10 lakhs the interest gained will be approximately Rs.60,000-Rs.65,000 only so it will be required to augment the corpus to that tune. Dr Raja Sabapathy said that yes we will tell him that and he should be willing and he will be willing to augment the corpus to that tune that will generate the interest of up to 1 lakh for the awardee. Dr Surajit said that that's a very generous gesture on part of Dr Guha and association thanks him for the same.

Secretary Dr Parag Sahasrabudhe requested Dr Vinita Puri and Dr Viraj Tambwekar to comment on Dr. Tambvekar fellowship- augmentation of the corpus. Dr Vinita Puri said that we have already

agreed to augment the corpus to 10 lakhs of rupees but we need a timeframe of six months. Dr Viraj Tambvekar said that we have communicated to all the alumni and it will take some time for them to respond whatever is the shortfall after the alumni contribute I assure this august body that I will complete the amount so that the final corpus is raised to 10 lakhs of rupees the general body applauded for a generous gesture by Dr Viraj Tambvekar.

Dr PK Bilwani at this juncture said that when the funds are raised it is hurting the sentiments of the donor so this raising the corpus should be restricted only to new awards and not existing awards. Dr Surajit Bhattacharya said that we have exactly done the same- honoured the sentiments of the donors. We have requested people to augment the corpus so that the awardee gets a reasonable sum of the award . Wherever the name has been dropped it is with full consent of the donor.

Dr Parag Sahasrabudhe explained that he personally has talk to all the award in status and return to them and the association had talk with all award in staturs and have given them three options regarding the restructuring of the award ,first was to augment the corpus to whatever amount is required , second was to look for a sponsor to augment the corpus and third if both the things are not possible then consider merging their award with some other award corpus so that the final aim is to give a reasonable amount of money to the awardee. Dr Lalit Makhija said that in the presentation made by the executive trustee he has said that some of the award corpses are not being utilised why don't to use this corpus is to augment these awards . Dr Ahuja explained that the corpus that is not being utilised is of APSI education foundation which will now henceforth be utilised for publicity so there is no surplus . All these years the interest generated from APSI education foundation corpus was added back to the corpus to augment the corpus so there is no excess money available. All the corpses are earmarked.

Secretary Dr Parag Sahasrabudhe requested Dr Bilwani or any other member from Gujarat state chapter to comment about merging of scientific activity Gujarat fund corpus with the corpus of trainee fund to attend APSICON,,s. Dr Bilwani said that he will definitely consider augmenting the corpus of scientific activity of Gujarat Fund. But it should not be merged with any other fund nor should it be discontinued.

Dr. Lokesh Kumar said that requesting the donors to augment the corpus may not be feasible with each donor so we have to have a relationship with the industry which is much needed in today's scenario. We do not have stalls takers from big companies like Allergan Gladerma etc. It is important that association has a constant relation with them. Appoint a committee, allow them to display their products on a larger forum and it has to be a give and take relationship only then it will work for us. Dr Surajit suggested that Dr Lokesh should be the head of the committee and he should decide the committee which will talk with Pharma companies and get them on board .Dr Rajendra Nehete said that association with Pharma companies always comes with a tag .Ziess is not participating because their microscopes are not being sold -how is the association going to give assurance to them that their microscopes will be bought by our members. Dr Alok Sharma said that formalising a relationship with companies is not ethical and association should defer from it.

The secretary requested Dr Sandeep Sharma to comment about SN Sharma endowment lecture corpus augmentation. Dr Sandeep Sharma said that he will definitely look for sponsorships. We will augment the corpus and will give feedback to the executive before the midterm executive meeting.

Secretary requested Dr Adesh Basu and Dr Arun Ganguly to comment about status of M. Mukherjee oration and AC Ganguly lecture. Both of them were not present in the auditorium no one commented from West Bengal chapter .Dr Surajit Bhattacharya said that he has talked to Dr Chatterjee and they have agreed to arrange for a sponsor but APSI giving five lakh rupees initially to augment a corpus of Dr. M. Mukherjee oration is not feasible and the state chapter will have to look for sponsorship by themselves.

Secretary requested Maharashtra state chapter members to comment about the proposal of transferring to corpus to APSI. Dr Jiten Kulkarni was not present. He then said that as the Maharashtra state

meeting is scheduled in January the decision of the general body will be conveyed to the midterm executive but in principle the Maharashtra state chapter agrees to whatever is being proposed by the award restructuring committee.

The secretary requested the UP chapter to comment about Dr. R N Sharma symposium. Professor A.

K. Singh said that he wishes that both the corpus of Dr. R N Sharma symposium and scientific activity of UP fund should not be merged and should be kept separate. He assured the house that the corpus of Dr. R N Sharma symposium will be augmented with savings of APSICON 2018 as he has already talked with the current president Dr Surajit Bhattacharya.

The secretary requested Dr. Dhama to comment about augmenting corpus of Vasudhan Arjin fellowship in laser surgery. Dr Dhama was not present in the auditorium. Dr Surajit said that this is one award which is the most sought after even though the corpus is not augmented for this award we should continue with this award as the residents want to go and learn with Dr Dhama . The secretary informed that he had personal communication with Dr Dhama in the morning and he said that to his company cannot augment a corpus right away and he will think of doing the same in next two years time . Dr Aditya Agarwal said that why don't we start annual subscription to our members as it is done by international associations so that we have enough money to augment the corpus of various awards. Dr. Bhattacharya said that we have already thought about this and will come to it in due course of time.

Mr. Secretary requested Dr Surendra Patil to comment about augmenting corpus of CBK oration . As he was not present in the auditorium Dr. Ramakrishna Nair said that very few students of Prof CBK are living and it would be difficult to augment the corpus of this award so the association should think of augmenting it by looking for a sponsor but name of Dr CBK should remain. Dr Surajit Bhattacharya said that he had a word with Dr Ramesh Sharma and they are willing to augment the corpus of CBK oration. Dr Ramesh Sharma said that he will think of adding to the corpus only if this august body agrees that it would be called as PGIMER CBK oration the general body accepted the proposition made by Dr Ramesh Sharma unanimously

Secretary moved the first resolution.

The secretary informed that there have several hearings till date and showed a chart of dates and informed that most of the times hearings have been postponed for some or other reason. In last hearing on 29<sup>th</sup> Oct. 2018 Court was preoccupied with the Suits of the year 2006 and earlier so the matter was adjourned to 18 Dec. 2018. The secretary informed that following resolution was passed by the GB 2015

**E. Update on Complaint at Charity commissioner's office against APSI trust  
New inquiry notice received on complaint made by Dr. Gupta**

The secretary informed that in this complaint again same thing is happening that matter is getting postponed. In the hearing held on 28 Aug. 2018 Dr. Gupta has made allegations against joint charity commissioner so she has referred the matter to charity commissioner.

He further said that he received an Email from Office of the Assistant Commissioner of Police Crime Branch- Daryaganj - Kotwali Delhi asking him to be present in Delhi to give statement regarding complaint made by Dr. Gupta. The secretary was not in country at that point in time so he asked for time and copy of the complaint by replying to the email . He further informed that there has been no reply to his mail.

He informed that GB that there has been new complaint and inquiry notice received from Charity commissioner's office Mumbai regarding another complaint by Dr. Gupta. He said that he along with Dr. Ranade, Dr. Thatte and Dr. Ahuja visited Mumbai Charity

commissioner's office on 14<sup>th</sup> August 2018 and showed required documents to the Inspector in consultation with our Lawyers. After seeing all the documents and listening to our explanation the inspector said that the same matter is sub judice in charity commissioner's office so same complaint cannot be enquired again. The inspectors said that he will get back to APSI if required.

The secretary informed that Dr. Gupta has raised Complaint to ASI regarding APSI's registration as separate body .The secretary said that he received email from Dr Chanjiv Singh

– Governing council member ASI asking for some documents which he provided to Dr Chanjiv Singh.

The secretary further said that Dr. Gupta has made new complaint against incoming president Dr. Amresh Baliarsing. He requested for some documents which were given to him by the secretarial office.

Dr Ahuja said that he would like to clarify on some of the complaints which the secretary just explained. He informed that along with the complaint to the assistant commissioner of police crime branch Daria Ganj Delhi there was a complaint filed against him at Preet Vihar police station in the area of his

residence. He further said that the complaint was that we i.e. me along with Dr Sridhar and Dr Khazanchi , Dr Sridhar being executive trustee at that point in time have siphoned off money from IPRAS. He has made repeated complaints at various authorities so every time there is fresh enquiry. All these complaints have been frivolous and there is no substance in them. He further said that we have filed a reply on our behalf and we have been informed that the matter has been closed by the police. We do not have a closure report as the closure report goes to the person who makes the complaint so it has gone to Dr Ashok Gupta. As per advice from our lawyers we are filing an RTI to get the closure report. All these expenses have been paid from our own pocket or from our well-wishers and acquaintances and no money of APSI has been spent on this matter. As regards to complaint made to ASI saying that APSI has separated illegally from ASI , Dr Chajiv sing asked for the



termination letter of Dr. Gupta and the secretary immediately send the required documents to him as they wanted it during the . We have been told that this matter is also closed although we do not have minutes of the said ASI meeting as it is not very easy to obtain these minutes.

Dr Ahuja said that Dr Gupta is making repeated and same complaints to ASI, police stations and various authorities. He's attacking the past executive trustee, current executive trustee and the members of the executive because he's trying to arm twist and blackmail each one of us individually so that he can be redeemed and taken back into the association and some sort of negotiation should be initiated by us so that he can be taken back into the APSI.

Dr Amresh Baliarsing explained about the complaint made by Dr Ashok Gupta against him. He said that he received an memo from the dean and was asked for an explanation regarding whether he has used any official stationery of the college during communications made during APSICON 2013 when he was scientific committee chairman. to which Dr Amresh said that he has not used any hospital letter heads for the communication so after his explanation this complaint has also been closed.

Dr Sandeep Sharma asked that if Dr Gupta is making complaint after complaints why are we not attacking Dr Ashok Gupta rather than just defending to his complaints Dr Ahuja said that currently I will defend myself, my trust, my association because this is question of my honour, my associations honour . Dr Gupta has been expelled by two third majority by members of this Association and I will defend the decision taken by this general body till my last breath until the time the association decides that Dr Gupta has to be taken back into the association. Members of the general body applauded.

Dr Lokesh Kumar said that he thinks that this matter has to be discussed beyond the sentiments because the general body runs on sentiments .We have to decide once for all because the association has to see its own interest. The legal cases benefit nobody but only the lawyers. He said that at no point he is favouring Dr Ashok Gupta as Dr Ashok Gupta has a big ego and what he is doing is absolutely wrong but why should our association suffer for the same.

Dr Ahuja said that we are not working on sentiments because I have been under attack or Dr Khazanchi or Dr Sridhar or Dr V Bhattacharya has been under attack but it is about the honour of the Association. Dr Gupta has attacked Association of plastic surgeons of India , the very existence of its body- do we have a right to defend that or we don't have a right to defend that, Otherwise we go to him with folded hands and request him to come back to Association and allow him to rule.

Dr. Alok Sharma said that Dr. Ashok Gupta had complained against him also. There is a legal solution to this that Dr Gupta can be restrained from filing complaints against the members of the Association.

Dr Surajit Bhattacharya said that legal solution will come after it has outlived both the sides as the civil suit will go on for years together so we have to be very practical.

Dr Lokesh said that we have to discuss the root of the problem and solve the problem. Today he has filed 10 different complaints you respond to the same- tomorrow he's going to file several more. We have to have a committee of the senior members of the association to solve the problem. Dr Gupta was pushed to the wall and he has retaliated. We all know that the solution comes out only after discussion.

Secretary Dr Parag Sahasrabudhe informed the general body that such a committee under leadership of Dr Karoon Agarwal and Dr Jiten Kulkarni was formed in 2015 by Dr Prabha Yadav then sitting president and they came back after talking to Dr. Gupta and expressed inability to proceed further as Dr. Gupta was ready to talk at that point in time. Dr Lokesh said that the situations may have changed now so we should have a fresh effort to negotiate now.

Dr Ahuja asked has the reality changed? He is still making several complaints against several members of the Association and his actions today are far more aggressive than the previous ones.

Dr Rakesh Khazanchi said that Dr Lokesh is saying that we have pushed Dr Ashok Gupta to the wall as if we are criminals .Have we done any crime by terminating his membership for the actions and deeds that he did in the past. He is blackmailing the association by putting cases so that we approach him with folded hands so we have to fight these cases and whenever the cases get resolved the issue will be solved.

Dr Alok Sharma said that not only he is attacking office bearers bus he is attacked me as well. If you get such a blackmailer person back into the Association he is going to create further chaos and this is the time when the association should stand united and fight against the cases filed by him.

Dr Mukunda Reddy said that who is getting worked up here whether it is Dr Lokesh or the members of the association as it seems that the members of the Association want to fight the cases and it is Dr Lokesh who has become restless.

Dr Prabha Yadav said that when all these things happened I was president of the Association. Dr Surajit Bhattacharya is doing so much, organising conference, introducing new seminars etc but I had no time in that year apart from visiting lawyers to get caveat for my conference so that Dr Gupta doesn't get stay on my conference. It was first time in my life that I visited the lawyer's office and that time I regretted being in the chair of president. Dr. Gupta has the audacity to complain against me that my degree is incorrect and I am practising as plastic surgeon illegally, when he has worked with me for 25-30 years. We had given him enough chances. When Dr Karoon came back after talk with Dr. Gupta he said that you just cannot talk to that person as he doesn't listen. So all negotiations failed at that point in time. We have to remember that we have not gone to the court; he has gone to the court. Is it not our right to fight the cases and defend them?

Dr V Bhattacharya said that Dr Lokesh said that the scenario must've changed- this slide itself shows that he is still making fresh complaints and Dr Lokesh also said that he has nothing to lose I would just add that he has" nothing else to lose".

Dr Samir Kumta said that we are talking about the cases which will go on for years together and outlive us . This is an association- I think the association will outlive both Dr Gupta and any individual member so we have to fight these cases for the sake of the Association.

Dr. Lokesh said that if the Association has decided to fight these cases then all the members should contribute Rs 5000- Rs.10,000 towards legal fees rather than using the money from the corpus of this Association. Secretary Dr Parag Sahasrabudhe

explained that in 2014 a buffer fund of 5% savings of each APSICON was formed and this is the fund from which legal expenses are being currently managed. Dr. Ahuja explained that this buffer fund was originally formed when he was secretary of the Association by Prof. Dr Goleria and for some reason 5% savings of each APSICONS were not going to this fund, so when he became executive trustee I just to revived the same as I could foresee litigations for the association in the future.

Dr Selva Seetharaman said that why does the association not file defamation suit against Dr Ashok Gupta and go on the offensive. Dr Ahuja explained that we have had discussions with our lawyer regarding the same and our lawyers have advised that filing defamation suits will bleed the association financially and it would be difficult to Prove the same so at this juncture we have to continue defending the cases as lawyers see that there is no substance in any of the complaints made by Dr Ashok Gupta. Dr Surajit Bhattacharya said that we had enough discussion on this topic. The secretary moved following resolution

***Resolved that if there is legal action against APSI and / or against current or past E C members, or against any other member of APSI by Dr. Ashok Gupta, APSI will be responsible for fighting the legal battle on behalf of the members and the Association.***

#### 18. Any other matter with permission of the chair.

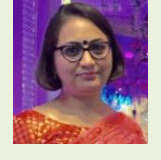
